

The City of Plymouth
(Traffic Regulation and Street Parking Places)
(Amendment No. 2004.18 – Pedestrian Zone Theatre Royal/The
Bank (ph) Area) Order 2004

The City of Plymouth in exercise of their powers under the relevant sections of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, and after consultation with the chief officer of police in accordance with Schedule 9 to the Act of 1984, hereby make the following Order:

This Order may be cited as The City of Plymouth (Traffic Regulation and Street Parking Places) (Amendment No. 2004.18 – Pedestrian Zone Theatre Royal/The Bank (ph) Area) Order 2004 and shall come into operation on the **5th day of July 2004**.

This Order amends “The City of Plymouth (Traffic Regulation and Street Parking Places) (Consolidation) Order 2004 as follows:

In the Articles to this Order

- 1) That *City Centre Theatre Royal Area Zone CCA* be added to Part I (provisions Relating to Parking Permits and Tickets) in the correct alphabetical sequence:
 - a) in Table 65 – Zones eligible for Resident’s Permits
 - b) in Table 72 – Zones eligible for Business Permits
- 2) That the following be added to Part K (Zonal Eligibility For Permits And Parking) in the correct alphabetical order:

Zone CCA-City Centre Theatre Royal Area

Parking Permit Applicants having an address in this column	may purchase a relevant Parking Permit to park without time limit in the area between Royal Parade, Theatre Royal, Old George Street, The Bank (P.H.) and the Civic Centre Car Park.
The Bank (P.H.) Old George Street Theatre Royal Royal Parade	

The following items be added to the specified Schedules in the correct alphabetical Order:

Schedule No. 1.10 (No Waiting At Any Time)

Area between Royal Parade, Theatre Royal, Old George Street, The Bank (Public House) and the Civic Centre Car Park

- i) On all sides for their entire lengths

Schedule No. 9.14 (No Loading/Unloading At Any Time with an exemption for vehicles (as shown in brackets).

Area between Royal Parade, Theatre Royal, Old George Street, The Bank Public House and the Civic Centre Car Park

- i) On all sides for their entire lengths (exemption for vehicles loading/unloading to/from neighbouring properties, vehicles maintaining or cleaning Public Services in the same area or vehicles displaying the appropriate Zone CCA Permit).
