

THE CITY OF PLYMOUTH
(TRAFFIC REGULATION AND STREET PARKING PLACES)
(AMENDMENT No. 2004.17 – CATTEDOWN ROAD AREA CPPZ)
ORDER 2004

The City of Plymouth in exercise of their powers under the relevant sections of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act of 1984, hereby make the following Order:

This order may be cited as the The City Of Plymouth (Traffic Regulation And Street Parking Places) (Amendment No.2004.17 – Cattedown Road Area CPPZ) Order 2004, and shall come into operation on the **5th day of July 2004.**

This Order amends The City of Plymouth (Traffic Regulation and Street Parking Places) Consolidation Order 2004 as follows:

a) In The Articles to this Order

1. That Cattedown Road Zone BB be added to Part I (provisions Relating to Parking Permits and Tickets) in the correct alphabetical sequence:-
 - a) in (Table 65) – Zones eligible for Resident’s Permits;
 - b) in (Table 82) – Zones eligible for Essential Workers Permits;
 - c) in (Table 92) – Zones eligible for Essential Visitor Permits;
 - d) in (Table 106) – Zones eligible for Daily Resident Visitor Tickets.
2. That the following be added to Part K (Zonal Eligibility For Permits And Parking) in the correct alphabetical order

Zone BB – CATTEDOWN ROAD

Parking Permit applicants having an address in this column	may purchase a relevant Parking Permit to park without time limit in designated parking places in a road from this column
Cattedown Road nos. 91 – 111 (odd nos. only)	Cattedown Road

3 That the following be added to Article 3 in the correct numerical sequence

PART 23 **between 7:00am and 5:00pm on Mondays to Fridays** any such day not being Christmas Day, Good Friday or a Bank Holiday being a public holiday, in any restricted road specified in Part 23 of the Second Schedule to this Order;

PART 24 **between 2:00pm and 4:00pm on Mondays to Saturdays** any such day not being Christmas Day, Good Friday or a Bank Holiday being a public holiday, in any restricted road specified in Part 24 of the Second Schedule to this Order;

PART 25 **between 8:00pm and midnight, and midnight and 8:00am** any such day not being Christmas Day, Good Friday or a Bank Holiday being a public holiday, in any restricted road specified in Part 25 of the Second Schedule to this Order;

PART 26 **between 8:00am and 6:00pm on Mondays to Fridays** any such day not being Christmas Day, Good Friday or a Bank Holiday being a public holiday, in any restricted road specified in Part 26 of the Second Schedule to this Order;

b) In The Schedules to this Order

The following items be added to the specified Schedules in the correct alphabetical order

Schedule No

1.10 No Waiting At Any Time

Cattedown Road

- (i) the east side from a point 65 metres south of its junction with South Milton Street for a distance of 5 metres in a southerly direction
- (ii) the east side from a point 2 metres south of its junction with South Milton Street for a distance of 2 metres in a southerly direction
- (iii) the west side from a point 61 metres south of its junction with South Milton Street for a distance of 18 metres in a southerly direction
- (iv) the west side from its junction with Clovelly Road for a distance of 6 metres in a southerly direction

South Milton Street

- (i) the south side from its junction with Cattedown Road for a distance of 31 metres in an easterly direction
- (ii) the south side from its junction with Beech Avenue westwards for a distance of 6 metres and eastwards for a distance of 11 metres
- (iii) the south side from its junction with Milton Court for a distance of 6 metres in a westerly direction and for a distance of 7 metres in an easterly direction
- (iv) the south side from its junction with Elliott Road to a point 24 metres west of its junction with Oakfield Terrace Road

Tresillian Street

- (i) the south side from a point 49 metres east of its junction with Cattedown Road for a distance of 19 metres in an easterly direction

Alvington Street

- (i) the north side from its junction with Elliott Road to a point 17 metres west of its junction with Oakfield Terrace Road
- (ii) the south side from its junction with Elliott Road for a distance of 70 metres in a westerly direction

Cattedown Road

- (i) the east side from a point 5 metres south of its junction with Mainstone Avenue to a point 5 metres south of its junction with Julian Street
- (ii) the east side from a point 15 metres north of its junction with Tresillian Street to a point 11 metres north of its junction with South Milton Street

Oakfield Terrace Road

- (i) the south-west side from a point 7 metres south-east of its junction with Alvington Street to a point 25 metres north-west of its junction with Tresillian Street
- (ii) the south-west side from a point 47 metres north-west of its junction with Tresillian Street to its junction with Julian Street

South Milton Street

- (i) the north side from a point 162 metres east of its junction with Cattedown Road for a distance of 16 metres
- (ii) the south side from a point 6 metres west of its junction with Beech Avenue to a point 31 metres east of its junction with Cattedown Road

Tresillian Street

- (i) the north side from its junction with Cattedown Road for a distance of 30 metres in an easterly direction
- (ii) the north side from a point 56 metres east of its junction with Cattedown Road for a distance of 21 metres
- (iii) the south side from its junction with Cattedown Road for a distance of 27 metres in an easterly direction

Schedule No

2.23 No Waiting Mon-Fri 7am-5pm

Home Sweet Home Terrace

- (i) the east side from a point 35 metres north of its junction with Home Sweet Home Terrace for a distance of 10 metres

Schedule No

8.03 Permit Parking Mon-Sat 9am-7pm

Cattedown Road

- (i) the east side from a point 4 metres south of its junction with South Milton Street for a distance of 59 metres in a southerly direction
- (ii) the west side from a point 40 metres south of its junction with Clovelly Road for a distance of 21 metres in a southerly direction

The following items be deleted from the specified Schedules

1.10 No Waiting At Any Time

South Milton Street

- (i) *the south side from the junction with Cattedown Road to a point 11 metres east of the junction with Beech Avenue*
- (ii) *the south side from a point 37 metres west of the junction with Oakfield Terrace Road to the junction with Elliott Road*
- (iii) *the south side from a point 11 metres west to a point 15 metres east of the junction with Milton Court*

- (i) *the south-west side from the junction with Julian Street to a point 7 metres south-east of its junction with Alvington Street*

South Milton Street

- (i) *the north side from a point 157 metres east of the junction with Cattedown Road for a distance of 21 metres in an easterly direction*

Tresillian Street

- (i) *the north side from the junction with Cattedown Road for a distance of 77 metres*
- (ii) *the south side from the junction with Cattedown Road for a distance of 32 metres*
