The City of Plymouth in exercise of their powers under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Schedule 9 to the Act of 1984, hereby make the following Order:

The City of Plymouth (Traffic Regulation and Street Parking Places) (Amendment No. 2004.26 – Barbican 2 Area - Lambhay Hill, Lambhay Street and Castle Street) Order 2004.

This shall have the affect to amend "The City of Plymouth (Traffic Regulation and Street Parking Places)(Consolidation) Order 2004 as follows

In The Articles to this Order

- 1. That "Barbican (Lambhay Hill, Castle Street etc)" be renamed "Barbican 2 (Lambhay Hill/Lambhay Street/Castle Street)" in tables 65, 82 and 92 in part I (Provisions Relating to Parking Permits and Tickets).
- 2. That "Barbican 2 (Lambhay Hill/Lambhay Street/Castle Street)" be added to the following tables in Part I in the correct alphabetical sequence :
 - a) Table 72 (Zones eligible for business permits);
 - b) Table 106 (Zones eligible for Daily Resident Visitor Ticket).
- 3. To delete Article 67(1) "Specific addresses from which applications are limited or cannot be made" and replace it with the following
 - 67.(1) Any property in the zones listed in table 67.1 (other than those listed in article 67.(2)) which have an off street parking facility (whether available for use or not) will qualify for a number of permits (of any permit type available in that scheme) equal to the number of vehicles owned, used or currently taxed at that property less the number of off street spaces at that property.
