THE CITY OF PLYMOUTH (DRAKE CIRCUS AREA) (PROHIBITION OF TURNS AND PROHIBITION OF ENTRY) ORDER 2004

The Council of the City of Plymouth (hereinafter referred to as "the Council") in exercise of their powers under the relevant Sections of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

CITATION AND REVOCATION

- 1. A) This Order shall come into force on the 27 September 2004 and may be cited as The City of Plymouth (Drake Circus Area) (Prohibition of Turns and Prohibition of Entry) Order 2004.
- 2. No person shall cause or permit any vehicle proceeding in the roads specified in column 1 of Schedule 1 to make a right turn into the road specified in column 2 of the said Schedule to this Order.
- 3. No person shall cause or permit any vehicle proceeding in the roads specified in column 1 of Schedule 2 to make a left turn into the road specified in column 2 of the said Schedule to this Order.
- 4. No person shall cause or permit any vehicle proceeding in the roads specified in column 1 of Schedule 3 to make a U turn into the road specified in column 2 of the said Schedule to this Order.
- 5. No person shall cause or permit any vehicle proceeding in the entire length of the roads specified in column 1 of Schedule 4 to make a U turn into the road specified in column 2 of the said Schedule to this Order.
- No person shall cause or permit any vehicle to enter the roads specified in column 1 of Schedule 5 from a road as specified in column 2 of the said Schedule to this Order.
- No person shall cause or permit any vehicle proceeding in the length of road specified in column 1 of Schedule 6 to make a straight ahead movement into the road specified in column 2 of the said Schedule to this Order.
- 8 Nothing in this Order shall apply to:
 - a) any vehicle being used for fire/rescue service, ambulance police or South Western Power Distribution purposes in relation to Article 4.
 - b) any bus in relation to Article 2 where detailed in Schedule 1.
