# THE CITY OF PLYMOUTH (AMENDMENT 79.02 - A386 TAVISTOCK ROAD/PLYMBRIDGE ROAD AREA) (PROHIBITION OF TURNS AND ENTRY) ORDER 2005

The Council of the City of Plymouth (hereinafter referred to as "the Council") in exercise of their powers under the relevant Sections, Parts and Schedules of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

#### CITATION AND REVOCATION

- 1. A) This Order shall come into force on the 4<sup>th</sup> day of November 2005 and may be cited as The City of Plymouth (A386 Tavistock Road/Plymbridge Road Area) (Prohibition of Turns and Entry) Order 2005.
- 2. No person shall cause or permit any vehicle proceeding in the roads specified in column 1 of Schedule 1 to make a right turn into the road specified in column 2 of the said Schedule to this Order.
- 3. No person shall cause or permit any vehicle proceeding in the roads specified in column 1 of Schedule 2 to make a left turn into the road specified in column 2 of the said Schedule to this Order.
- 4. No person shall cause or permit any vehicle proceeding in the roads specified in column 1 of Schedule 3 to make a U-Turn into the road specified in column 2 of the said Schedule to this Order.
- 4a. No person shall cause or permit any vehicle from making a U-Turn at any part of the junction specified in Schedule 3a.
- No person shall cause or permit any vehicle to enter the roads specified in column 1 of Schedule 4 from a road as specified in column 2 of the said Schedule to this Order.
- 6 Nothing in this Order shall apply to:
  - a) any bus or taxi in relation to Article 2 where detailed (bracketed) in Schedule 1.
  - b) Any vehicle on an occasion when it is being used for fire brigade, ambulance or police purposes if the observance of any provision of this order would be likely to hinder the use of the vehicle for the purposes for which it is being used on that occasion.
  - c) Anything done with the permission, or at the direction of a police officer or traffic warden in uniform.

d) Any bus or taxi or other authorised vehicle (with the permission of the relevant Head of Transport) in relation to article 5 (i.e. Schedule 4).

This Order shall come into force on the 4<sup>th</sup> day of November 2005 and may be cited as The City of Plymouth (Amendment No. 79.02 – A386 Tavistock Road / Plymbridge Road Area)(Prohibition of Turns and Entry) Order 2005.
