1.1 No Waiting At Any Time

- (i) Access Roads (between Outland Road And Home Park), the south side side from a point 42 metres east of its junction with Outland Road for a distance of 170 metres in a north easterly direction (including its access arms).
- (ii) Alexandra Road (ford), the south side from the junction with Wolseley Road southwards for a distance of 54 metres.
- (iii) Citadel Road East, the north side from a point 37 metres west of the junction with Hoegate Streets to a point 5 metres east of the northern end of the closed end (outside no. 201)
- (iv) Citadel Road East, the south side from a point 5 metres east of the southern end of the closed western to a point 196 metres north and west of its junction with Hoe Road
- (v) East Street, the all side for there entire length .
- (vi) Oakfield Terrace Road, the north side from the Electricity Depot entrance to a point 22 metres south east of the Electricity Depot.
- (vii) Oakfield Terrace Road, the south side from the junction between Oakfield Terrace Road and Tresillian Street to a point 20 metres north west of the junction.
- (viii) Richmond Walk, the south side side from a point 37 metres west of its junction with the access road into Ocean Court westwards for a distance of 24 metres.
- (ix) Southside Ope, both sides for the entire length .

- (x) Staddon Terrace Lane, the north & west side from the north western corner of the rear lane (to the rear of No. 30 Bayswater Road) southwards for a distance of 7 meters and eastwards for a distance of 3 meters
- (xi) Sussex Road, the south side from a point 91 meters east of its junction with Alexandra Terrace eastwards for a distance of 7 meters.
- (xii) Tintern Avenue, the west side From a point 79 meters south of its junction with Embankment Road southwards for a distance of 8 meters.
- (xiii) Woolworths West Car Park Area, the east side from its cul-de-sac end in a northerly and then easterly direction for a distance of 32 metres.
- (xiv) Woolworths West Car Park Area, the east side from its junction with Cornwall Street in a southerly direction for 24 metres and then easterly for 2 metres.
- (xv) Woolworths West Car Park Area, the west side from its junction with Cornwall Street southwards for its entire length, including its cul-de-sac end.

- (i) Oakfield Terrace Road, the north-east side from the entrance to the Electricity Depot to a point 12 metres north west of the Electricity Depot
- (ii) Oakfield Terrace Road, the south side from the Oakfield Terrace Road and Alvington Street junction to a point 7 metres south east of the junction.
- (iii) Oakfield Terrace Road, the south-east side from the Oakfield Terrace Road and Alvington Street junction running north west to the Oakfield Terrace Road and Tresillian Street junction

6.01 Goods Loading Bay At Any Time

- (i) Woolworths West Car Park Access Road, the south side boundary of the car park from its eastern boundary for a distance of 24 metres in a westerly direction, all that extent bounded on its western and northern side by a road marking conforming to diag. No. 1028.3 of the TSRGD 2002 and having a width of approximately 11 metres.
- (ii) Woolworths West Car Park Area, the northern side boundary of the car park, from its eastern boundary for a distance of 21 metres in a westerly direction. All that extent bounded on its western and southern side by a road marking conforming to diag. No. 1028.3 of the TSRGD 2002 and having a width of approximately 3 metres throughout.
- (iii) Woolworths West Car Park Area, the south side boundary of the car park, between points 24 metres and 35 metres west of its eastern boundary, all that extent bounded on its northern and western side by a road marking conforming to diag. No. 1028.3 of the TSRGD 2002 and having a width of approximately 4.5 metres throughout.

- (i) Woolworths West Car Park Area, the all side that area of the car park bounded by points; (i) 6metres south of the northern boundary and 7 metres east of the western boundary, (ii) 6 metres south of the northern boundary and 17.5 metres east of the western boundary, (iii) 22.5 metres south of the northern boundary and 7 metres east of the western boundary and (iv) 22.5 metres south of the northern boundary and 17.5 metres east of the western boundary.
- (ii) Woolworths West Car Park Area, the east side boundary, between points 3 metres and 22.5 metres south of its northern boundary.
