The Council of the City of Plymouth in exercise of their powers under the relevant Sections, Parts and Schedules of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Schedule 9 to the Act of 1984, hereby make the following Order:

THE CITY OF PLYMOUTH (AMENDMENT No. 2005.11 –TREVITHICK ROAD AREA) (PROVISION OF ONE-WAY ROADS AND PROHIBITION OF TURNS AND ENTRY) ORDER 2005

This shall have the effect to amend "The City of Plymouth (Traffic Regulation and Street Parking Places) (Consolidation) Order 2004 as follows:

1) The following Moving Traffic Restrictions, Speed Limit and Prohibition Types **be** added to the Articles to this Order in the appropriate sequence.

PART M MOVING TRAFFIC RESTRICTIONS, SPEED LIMITS AND PROHIBITIONS

ONE-WAY

Save specific classifications of vehicles as shown in brackets adjacent to the location of the one-way (if appropriate) in the Two Hundred and First Schedule and as provided in part H to this Order no person shall cause or permit any vehicle to proceed in any of the roads specified for the lengths specified in Column 1 other than in the direction specified in Column 2 of the **Two Hundred and First Schedule** to this Order.

PROHIBITION OF TURNS

Save specific classifications of vehicles as shown in brackets adjacent to the location of the prohibition (if appropriate) in the Two Hundred and Third Schedule and as provided in part H to this Order no person shall cause or permit any vehicle proceeding in the roads specified in Column 1 of the following parts of the **Two Hundred and Third Schedule** to this Order to make the turn specified in the following parts into the road specified in column 2 of that schedule.

- PART 1 **No Right Turn** from any road specified to any road specified in Part 1 of the Two Hundred and Third Schedule to this Order;
- PART 2 **No Left Turn** from any road specified to any road specified in Part 2 of the Two Hundred and Third Schedule to this Order;
- PART 3 **No 'U' Turn** from any road specified to any road specified in Part 3 of the Two Hundred and Third Schedule to this Order;

PROHIBITION OF ENTRY

Save specific classifications of vehicles as shown in brackets adjacent to the location of the prohibition (if appropriate) in the Two Hundred and Ninth Schedule and as provided in part H to this Order no person shall cause or permit any vehicle to enter any of the roads specified in Column 1 from a road or roads specified in Column 2 of the **Two Hundred and Ninth Schedule** to this Order.

2) The following items be added to the specified Schedules to this Order in the appropriate sequence.
