The Council of the City of Plymouth in exercise of their powers under the relevant Sections, Parts and Schedules of the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Schedule 9 to the Act of 1984, hereby make the following Order:

The City of Plymouth (Traffic Regulation and Street Parking Places) (Amendment No. 2005.10 – Eggbuckland Road/Delamere Road Safer Journey to Schools) Order 2006

1.1 No Waiting At Any Time

- (i) Deer Park Drive, the east & north side from a point 97 metres west of the extension of the western kerbline of Oregon Way westwards and northwards to its junction with Eggbuckland Road.
- (ii) Deer Park Drive, the south side from a point 97 metres west of its junction with Oregon Way westwards to its junction with Eggbuckland Road
- (iii) Delamere Road, the north side from its junction with Eggbuckland Road eastwards to a point 30 metres east of its junction with Carradale Road.
- (iv) Eggbuckland Road, the east side from a point 38 metres south of its junction with Delamere Road southwards for a distance of 26 metres.
- (v) Eggbuckland Road, the north & west side from a point 100 metres north of its junction with Frogmore Avenue southwards and westwards to a point 78 metres west of its junction with Donnington Drive
- (vi) Eggbuckland Road, the south side from a point 35 metres west of its junction with Michigan Way (road now closed) eastwards to a point 105 metres east of the eastern kerb line of the island at Deer Park Drive/ Eggbuckland Road junction
- (vii) Frogmore Avenue, the north side from a point 24 metres west of its junction with Eggbuckland Road westward for a distance of 10 metres.
- (viii) Frogmore Avenue, the south side from its junction with Eggbuckland Road westwards for a distance of 35 metres.

- (iv) Eggbuckland Road, the north & west side, from a point 78 metres west to a point 50 metres east of the junction with Donnington Drive
- (v) Eggbuckland Road, the north & west side, from a point 71 metres south to a point 54 metres north of the junction with Frogmore Avenue
