

**THE CITY OF PLYMOUTH (TRAFFIC REGULATION  
AND STREET PARKING PLACES) (AMENDMENT No.  
2009.01 DERRIFORD CONTROLLED PERMIT  
PARKING ZONE) ORDER 2009**

Plymouth City Council in exercise of their powers under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act of 1984, hereby make the following Order:

PLYMOUTH CITY COUNCIL (TRAFFIC REGULATION, STREET PARKING PLACES AND CLEARWAYS) (AMENDMENT No. 2009.01 VARIOUS ROADS IN EGGBUCKLAND AND MOORVIEW) ORDER 2009

This shall have the effect of amending "The City of Plymouth (Traffic Regulation and Street Parking Places)(Consolidation) Order 2004" as follows:

1) In the Articles to this order:

i) That Derriford JJ be added to Part I (provisions Relating to Parking Permits and Tickets) in the correct alphabetical sequence:-

- a. in (Table 65) – Zones eligible for Resident's Permits;
- b. in (Table 92) – Zones eligible for Essential Visitor Permits;
- c. in (Table 106) – Zones eligible for Daily Resident Visitor Tickets

ii) That the following be added to Part K (Zonal Eligibility For Permits and Parking) in the correct alphabetical order

Zone JJ – Derriford

Parking Permit applicants having an address in this column	may purchase a relevant Parking Permit to park without time limit in designated parking places in a road from this column

### **1.1 No Waiting At Any Time**

- (i) Challock Close both sides from its junction with Rogate Drive for a distance of 10 metres in a north-westerly direction.
- (ii) Findon Gardens, both sides from its junction with Rogate Drive for a distance of 10 metres in a south-easterly direction.
- (iii) Rogate Drive, the south & west side from a point 77 metres south of its junction with Challock Close for a distance of 20 metres in a northerly and then westerly direction (to cover the junction of the southern turning head).
- (xiii) Rogate Drive, the west & north side from a point 48 metres from its junction with Challock Close for a distance of 26 metres in a southerly and then south-westerly direction (to cover the junction of the northern turning head).
- (xiv) Rogate Drive, the southeast side from its junction with Miller Way to a point 89 metres south west of that junction.
- (xv) Rogate Drive, the west side from its junction with Miller Way to a point 10 metres southwest of that junction
- (xvi) Rogate Drive, the northwest side from a point 10 metres northeast of its junction with Challock Close to a point 10 metres southwest of that junction.
