

**THE CITY OF PLYMOUTH
(TRAFFIC REGULATION AND STREET PARKING PLACES)
(AMENDMENT No. 2010.1001237 – PERMIT CHARGES)
ORDER 2010**

The City of Plymouth in exercise of their powers under the relevant sections of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act of 1984, hereby make the following Order:

The City Of Plymouth (Traffic Regulation And Street Parking Places) (Amendment No.2010.1001237 – Permit Charges) Order 2010.

This Order amends The City of Plymouth (Traffic Regulation and Street Parking Places) Consolidation Order 2004 as follows:

a) In The Articles to this Order

1. That Article 32 be deleted and replaced with:

32. Save as provided in PART H to this Order no person shall, except upon the direction of a police constable in uniform cause or permit any vehicle which is not displayed in the relevant position a valid Parking Zone Permit displaying where applicable the correct zone identification letter(s) for the zone as defined in PART K to this Order and wait during the permitted hours as specified in the Eighth Schedule to this Order.

2. That Article 105 be deleted and replaced with:

105. Any resident the postal address of which is within the Zone listed in Table 78 to this Order may apply to the Council for the issue of a pre-paid Daily Resident Visitor Ticket for a vehicle belonging to a person or persons being a visitor to that residence. Such application shall be made on a form issued by and obtainable from the Council and shall include particulars and information required by such form to be supplied. A Daily Resident Visitor Ticket will be valid for one day and the issue of such tickets be limited to a maximum of **90** tickets per 12 month period per postal address.

3. That Article 81A be added between Articles 81 and 82 as follows:

81A. The Essential Worker's Permit will only be valid when displayed with a completed Essential Worker Permit Form for the duration of waiting. An Essential Worker Permit Form (issued by the Council) should be completed upon arrival to include particulars and information required by such form and should be clearly displayed on the dash of the vehicle.

4. That Article 70 be deleted and replaced with:

70. Any business that requires a person employed by that business being the owner of a vehicle, used solely for the purpose associated with the business and having insufficient available off street parking either within the premises or nearby and whose business address lies within the Zones listed in Table 72 and specified in the PART K to this Order, may apply to the Council for a Parking Permit, subject to compliance with the current conditions of use of such permits. Such applications shall be made on a form issued by and obtainable from the Council and shall include the particulars and information required by such form to be supplied and shall be accompanied by the appropriate remittance.

5. That Articles 70A and 70B be added between Articles 70 and 71 as follows:

70A. A Business Permit will only be valid when displayed in the relevant position with a parking clock (issued by the Council) (on which the driver, or other person in charge of the vehicle, has set the time on the clock at which the period of waiting began and displayed for the duration of waiting).

70B. A Business Permit will only be valid for a period not exceeding 2 hours, not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in that length of road.

6. That Article 112 be deleted and replaced with:

112. "appropriate remittance" means a remittance for the sum as specified in table 112A for those periods that relate to the permit or ticket which is valid in one or more of the designated parking places referred to in the Schedules to this Order.

7. That Table (112A) appropriate remittance, be added after Article as follows:

8. That Article 100 be deleted and replaced with:

100. The charge for Daily Visitors Tickets for Hotel/Guest Houses referred to in Article 98 of this Order shall of a fee determined by Article 112 to this Order. A completed prepaid permit, issued by the Council, shall be valid for one days use and should be completed in the manner described on the permit and displayed for the duration of waiting.

b) In The Schedules to this Order

The following items be added to the specified Schedules in the correct alphabetical order:

Schedule No

1.10 No Waiting At Any Time

- (i) Cornwall Street Car Park Perimeter Road, both sides from its junction with Cornwall Street to a point 24 metres south of that junction
- (iii) Cornwall Street Car Park Perimeter Road, the east & north side from its most southeasterly corner for a distance of 23 metres in a northerly and westerly direction
- (vii) Cornwall Street Car Park Perimeter Road, the south side from a point 70 metres from its junction with Cornwall Street (in a southerly, easterly and southerly direction) for a distance of 20 metres in a westerly direction
- (xi) Cornwall Street Car Park Perimeter Road, the south side from a point 42 metres west of its most southeasterly point for a distance of 29 metres in a westerly direction
- (xv) Cornwall Street Car Park Perimeter Road, the west side from a point 130 metres from its junction with Cornwall Street (in a westerly, southerly and westerly direction) for a distance of 14 metres in a southerly direction

**4.05 Pay and Display Maximum Stay 4 Hours No Return within 1 hour 10am-6pm
Daily Visitor Ticket Holders Are Exempt**

- (i) Lockyer Street, the east side from a point 17 metres south of the junction with Citadel Road for a distance of 118 metres in a southerly direction.
- (ii) Lockyer Street, the west side from a point 8 metres south of the junction with Citadel Road for a distance of 86 metres in a southerly direction.
- (vii) Lockyer Street, the west side from a point 6 metres south of the junction with the Esplanade for a distance of 19 metres in a southerly direction.

Schedule No

6.01 Goods Loading Bay At Any Time

- (i) Cornwall Street Car Park Perimeter Road, the east & north side from a point 24 metres south of its junction with Cornwall Street for a distance of 106 metres in a westerly, southerly and westerly direction
- (iii) Cornwall Street Car Park Perimeter Road, the east & north side from a point 24 metres south from its junction with Cornwall Street for a distance of 46 metres in an easterly and southerly direction
- (vii) Cornwall Street Car Park Perimeter Road, the south side from its most south easterly point for a distance of 42 metres in a westerly direction

Schedule No

9.01 No Loading/Unloading At Any Time

- (i) Cornwall Street Car Park Perimeter Road, both sides from its junction with Cornwall Street to a point 24 metres south of that junction
- (iii) Cornwall Street Car Park Perimeter Road, the east & north side from its most southeasterly corner for a distance of 23 metres in a northerly and westerly direction
- (vii) Cornwall Street Car Park Perimeter Road, the south side from a point 42 metres west of its most southeasterly point for a distance of 29 metres in a westerly direction
- (xi) Cornwall Street Car Park Perimeter Road, the south side from a point 70 metres from its junction with Cornwall Street (in a southerly, easterly and southerly direction) for a distance of 20 metres in a westerly direction
- (xv) Cornwall Street Car Park Perimeter Road, the west side from a point 130 metres from its junction with Cornwall Street (in a westerly, southerly and westerly direction) for a distance of 14 metres in a southerly direction

202.3 Prohibition of Driving except for access

- (i) Cornwall Street Car Park Perimeter Road, all sides for its entire length.
