

**THE CITY OF PLYMOUTH (SPEED LIMITS) (AMENDMENT No.
2010.409822 – EAST END TRANSPORT PROJECT) SPEED ORDER 2010**

The Council of the City of Plymouth in exercise of their powers under Sections 84(1) and (2) and Part IV of Schedule 9 of the Road Traffic Regulation 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

**THE CITY OF PLYMOUTH (TRAFFIC REGULATION ORDERS) (AMENDMENT
No. 2010.409822 – EAST END TRANSPORT PROJECT) SPEED ORDER 2010**

This shall have the effect of amending "The City of Plymouth (Traffic Regulation and Street Parking Places) (Consolidation) Order 2004" as follows:

- 1) The following items be added to the specified Schedules in the correct alphabetical Order:

LIST OF SCHEDULES

205 Speed Limits

205.4 40mph Speed Limit

- (i) Billacombe Road both sides, from its junction with Elburton Road to its junction with the extended southern kerblines of The Ride
- (ii) Elburton Road both sides, from a point 53 metres northwest of its junction with Pennys Lane to its junction with Billacombe Road
- (iii) Embankment Road both sides, from its junction with Plymouth Road to a point 370 metres southwest of its junction with Lanhydrock Road

Items to be revoked from:

205.4 40mph Speed Limit

- (i) Billacombe Road both sides, from a point 39 metres west of the roundabout at the junction of Billacombe Road and Pomphlett Road for a distance of 903 metres westwards

**THE COUNTY OF DEVON (BILLACOMBE ROAD/ELBURTON
ROAD/LAIRA BRIDGE ROAD, PLYMOUTH) (40m.p.h. SPEED LIMIT)
ORDER 1976**

205.4 40mph Speed Limit

- (i) Billacombe Road both sides, from its junction with Laira Bridge Road to its junction with Elburton Road a distance measured along the said road of approximately 1,337 metres
- (ii) Elburton Road both sides, from its junction with Billacombe Road to a point 251 metres southeast of its junction with Springfield Road
- (iii) Laira Bridge Road both sides, from its junction with Billacombe Road in a westerly direction for a distance of 64 metres

Items to be revoked from:

The City of Plymouth (Plymouth Road and Embankment Road) (40m.p.h. Speed limit) Amendment and Consolidation Order 1999

- (i) Embankment Road, from its junction with Plymouth Road southwestwards to a point 119 metres southwest of its junction with Stanley Place
- (ii) Gdynia Way (Formerly Embankment Road Relief Road), from its junction with Embankment Road westwards to a point 15 meters east of the Cattedown Road Bridge
- (iii) Laira Bridge Road Link Road, from its junction with Laira Bridge Road to its junction with Gdynia Way (formerly Embankment Road Relief Road)
