THE CITY OF PLYMOUTH (TRAFFIC REGULATION ORDERS) (AMENDMENT No. 2009.409822 – EAST END TRANSPORT SCHEME) ORDER 2010

The City of Plymouth in exercise of their powers under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act of 1984, hereby make the following Order:

THE CITY OF PLYMOUTH (TRAFFIC REGULATION ORDERS) (AMENDMENT No. 2009.409822 – EAST END TRANSPORT SCHEME) ORDER 2010

This shall have the effect of amending "The City of Plymouth (Traffic Regulation and Street Parking Places) (Consolidation) Order 2004" as follows:

1) That the following be added to Article 35 (Limited Waiting Parking Places) in the correct numerical sequence:

PART 83 -

- a) Waiting limited to 30 minutes between the hours 9am and 5pm.
- b) Where a vehicle has been left in a designated parking place described in Part 82 of the Third Schedule to this Order and that vehicle is subsequently moved that vehicle is not permitted to return to that parking place until a period of **2 hours** has elapsed otherwise a penalty charge shall be payable in accordance with PART J to this Order. (See Articles 54 and 55 for Exemptions)
- 2) That the following be added to Article 46 (Loading/Unloading Only Bays) in the correct numerical sequence:
 - PART 7 those lengths of road specified in Part 7 are goods loading bays Monday to Friday 9am 5pm.
- 3) That Article 118 to be deleted and replaced with:

SAVE as provided in Article 119 and 120 to this Order, no person shall, except upon the direction of a police constable in uniform or Traffic warden, cause or permit any vehicle other than local services to proceed in a bus lane on such times as specified in the various parts to Schedule Two Hundred and Twelve to this Order.

- 4) That PART 2, PART 3, PART 4 and PART 5 of Article 118 be deleted
- 5) That the following be added to Article 118 (Reserved Bus Lanes) in the correct numerical sequence:
 - PART 1 At Any Time with an exemption for hackney carriages, private hire vehicles, motorcycles and pedal cycles in any restricted road specified in Part 1 of Schedule Two Hundred and Twelve to this Order
 - PART 2 At Any Time in any restricted road specified in Part 2 of Schedule Two Hundred and Twelve to this Order

- PART 3 Between 8am and 9.15am Mondays to Saturdays with an exemption for hackney carriages, private hire vehicles, motorcycles and pedal cycles in any restricted road specified in Part 3 of Schedule Two Hundred and Twelve to this Order:
- 6) That the following be added to Article 126 (Prohibition of Driving) in the correct numerical sequence:
 - PART 6 Prohibition of Entry Except for Local Buses to any road specified in Part 6 of the Two Hundred and Ninth Schedule to this Order;
