

**THE CITY OF PLYMOUTH (TRAFFIC REGULATION ORDERS) (AMENDMENT No.
2011.1284456 – TORRIDGE WAY) ORDER 2011**

The City of Plymouth in exercise of their powers under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act of 1984, hereby make the following Order:

THE CITY OF PLYMOUTH (TRAFFIC REGULATION ORDERS) (AMENDMENT No.
2011.1284456 – TORRIDGE WAY) ORDER 2011

This shall have the effect of amending "The City of Plymouth (Traffic Regulation and Street Parking Places) (Consolidation) Order 2004" as follows:

- 1) That the following be added to Article 3 (No Waiting for Periods Less Than At Any Time) in the correct numerical sequence:

PART 31 between 8.00am – 9.30am and 2.30pm – 4.00pm on Mondays to Fridays
any such day not being Christmas Day, Good Friday or a bank holiday being a public holiday, in any restricted road specified in Part 31 to the Second Schedule to this Order;

- 2) The following items be added to the specified Schedules in the correct alphabetical Order:

LIST OF SCHEDULES

- 1 No Waiting at Any Time**
- 2 No Waiting**
- 12 School Keep Clearway**

1.1 No Waiting at Any Time

- (i) Severn Place north side, from its junction with Torridge Way for a distance of 28 metres in an easterly direction
- (ii) Torridge Way east side, from a point 9 metres north of its junction with Highfield School to its junction with Severn Place in a southerly direction

2.31 No waiting 8.00am to 9.30am and 2.30pm to 4.00pm Monday to Friday

- (i) Torridge Way east side, from a point 25 metres north of its junction with the northern entrance to Highfield School for a distance of 16 metres in a southerly direction

12.01 School Keep Clearway at Any Time

- (i) Severn Place north side, from a point 53 metres east of its junction with Torridge Way for a distance of 37 metres in an easterly direction
- (ii) Torridge Way east side, from a point 10 metres north of its junction with Severn Place for a distance of 30 metres in a northerly direction
