

**THE CITY OF PLYMOUTH (TRAFFIC REGULATION ORDERS) (AMENDMENT No.  
2009.409822 (3) – EAST END TRANSPORT SCHEME) ORDER 2012**

The City of Plymouth in exercise of their powers under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act of 1984, hereby make the following Order:

The City of Plymouth (Traffic Regulation Orders) (Amendment No. 2009.409822 (3) – East End Transport Scheme) Order 2012

This shall have the effect of amending “The City of Plymouth (Traffic Regulation and Street Parking Places) (Consolidation) Order 2004” as follows:

- 1) The following items be added to the specified Schedules in the correct alphabetical Order:

## **1.1 No waiting at Any Time**

- (i) Cathcart Avenue both sides, from its junction with Grenville Road for a distance of 3 metres in a northerly direction
- (ii) Cattewater Road north side, from its junction with Elliott Road for a distance of 25 metres in an easterly direction
- (iii) Cattewater Road south side, from its junction with Elliott Road for a distance of 24 metres in an easterly direction
- (iv) Elliott Road east side, from its junction with River view to its junction with Cattewater Road
- (v) Elliott Road east side, from its junction with Cattewater Road for a distance of 53 metres in a southerly direction
- (vi) Elliott Road west side, from its junction with Mainstone Avenue for a distance of 95 metres in a southerly direction
- (vii) Elliott Road west side, from its junction with Mainstone Avenue for a distance of 18 metres in a northerly direction
- (viii) Embankment Road south side, from its junction with Tintern Avenue for a distance of 5 metres in an easterly direction
- (ix) Embankment Road south side, from a point 52 metres east of its junction with Tintern Avenue for a distance of 18 metres in an easterly direction
- (x) Grenville Road north side, from a point 10 metres west of its junction with Cathcart Avenue to a point 6 metres east of that junction
- (xi) St Judes Road east side, from its junction with Exeter Street for a distance of 7 metres in a northerly direction
- (xii) St Judes Road west side, from its junction with Exeter Street for a distance of 13 metres in a northerly direction
- (xiii) Tothill Road west side, from its junction with St Judes Road for a distance of 8 metres in a southeasterly direction
- (xiv) Tothill Road west side, from a point 18 metres southeast of its junction with St Judes Road for a distance of 14 metres in a southeasterly direction
- (xv) Wentworth Place both sides, from its junction with Grenville Road for a distance of 7 metres in a southerly direction

#### **2.04 No Waiting Mon-Sat 8am-6.30pm**

- (i) Cattewater Road north side, from a point 25 metres east of its junction with Elliott Road for a distance of 79 metres in an easterly direction
- (ii) Elliott Road east side, from a point 53 metres south of the junction with Cattewater Road to the junction with Oakfield Terrace Road
- (iii) Elliott Road east side, from its junction with River View to its junction with Radford Avenue
- (iv) Elliott Road west side, from a point 32 metres north to a point 30 metres south of the junction with Alvington Street

#### **2.14 No Waiting Mon-Sat 8am-5pm**

- (i) Cathcart Avenue both sides, from a point 3 metres north of its junction with Grenville Road to its junction with Brentor Road

### **3.04 Limited Waiting to 1 Hour No Return Within 3 Hours Mon-Fri 9am-5pm**

- (i) Embankment Road south side, from a point 20 metres east of its junction with Tintern Avenue for a distance of 20 metres in an easterly direction
- (ii) Embankment Road south side, from a point 46 metres east of its junction with Tintern Avenue for a distance of 6 metres in an easterly direction

**3.24 Limited Waiting to 1 Hour No Return Within 3 Hours Mon-Fri 10am-5pm**

- (i) Commercial Road southwest side, from a point 22 metres northwest of its junction with Teats Hill Road to a point 7 metres southeast of its junction with Commercial Ope

## **6.1 Goods Loading Bay at Any Time**

- (i) Embankment Road south side, from a point 5 metres east of its junction with Tintern Avenue for a distance of 15 metres in an easterly direction

**7.2 Disabled Parking Bay At Any Time Maximum Stay 2 Hours No Return for 2 Hours**

- (i) Embankment Road south side, from a point 40 metres east from its junction with Tintern Avenue for a distance of 6 metres in an easterly direction

#### **8.12 Permit Parking Mon-Fri 11am-12pm**

- (i) St Judes Road east side, from a point 7 metres north of its junction with Exeter Street for a distance of 55 metres in a northerly direction
- (ii) St Judes Road west side, from a point 13 metres north of its junction with Exeter Street to a point 3 metres south of its junction with Tothill Road
- (iii) Tothill Road west side, from a point 8 metres southeast of its junction with St Judes Road for a distance of 10 metres in a southeasterly direction
- (iv) Tothill Road west side, from a point 33 metres southeast of its junction with St Judes Road for a distance of 40 metres in a southeasterly direction

### **9.01 No Loading/Unloading at any time**

- (i) St Judes Road east side, from its junction with Exeter Street for a distance of 8 metres in a northerly direction
- (ii) St Judes Road west side, from of its junction with Exeter Street for a distance of 13 metres in a northerly direction
- (iii) Elliott Road east side, from its junction with River view to its junction with Cattewater Road
- (iv) Elliott Road east side, from its junction with Cattewater Road for a distance of 53 metres in a southerly direction
- (v) Elliott Road west side, from its junction with Mainstone Avenue for a distance of 95 metres in a southerly direction
- (vi) Elliott Road west side, from its junction with Mainstone Avenue for a distance of 18 metres in a northerly direction
- (vii) Embankment Road south side, from its junction with Tintern Avenue for a distance of 5 metres in an easterly direction
- (viii) Embankment Road south side, from a point 49 metres east of its junction with Tintern Avenue for a distance of 24 metres in an easterly direction
