## **1.1 No waiting at any time**

- (i) Carrolls Way both sides, from its junction with Staddiscombe Road for a distance of 10 metres in a southeasterly direction
- (ii) Kitter Drive both sides, from its junction with Staddiscombe Road for a distance of 10 metres in a northerly direction
- (iii) Shapley Gardens both sides, from its junction with Staddiscombe Road for a distance of 10 metres in a northerly direction
- (iv) Staddiscombe Road northwest side, from its junction with Wembury Road for a distance of 40 metres in a southwesterly direction
- (v) Staddiscombe Road northwest side, from its junction with Shapley Gardens for a distance of 50 metres in a northeasterly direction
- (vi) Staddiscombe Road northwest side, from its junction with Shapley Gardens for a distance of 145 metres in a southwesterly direction
- (vii) Staddiscombe Road northwest side, from its junction with Kitter Drive for a distance of 10 metres in a northeasterly direction
- (viii) Staddiscombe Road northwest side, from its junction with Kitter Drive for a distance of 10 metres in a southwesterly direction
- (ix) Staddiscombe Road southeast side, from its junction with Wembury Road for a distance of 40 metres in a southwesterly direction
- (x) Staddiscombe Road southeast side, from a point 73 metres southwest of its junction with Wembury Road to its junction with Carrolls Way
- (xi) Staddiscombe Road southeast side, from its junction with Carrolls Way for a distance of 35 metres in a southwesterly direction
- (xii) Wembury Road west side, from its junction with Staddiscombe Road for a distance of 30 metres in a northeasterly direction
- (xiii) Wembury Road west side, from its junction with Staddiscombe Road for a distance of 40 metres in a southwesterly direction
