

**THE CITY OF PLYMOUTH (TRAFFIC REGULATION ORDERS)

The City of Plymouth in exercise of their powers under the Road Traffic Regulation Act 1984, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Paragraph 20 of Schedule 9 to the Act of 1984, hereby make the following Order:

This shall have the effect of amending "The City of Plymouth (Traffic Regulation and Street Parking Places) (Consolidation) Order 2004" as follows:

- 1) The following items be added to the specified Schedules in the correct alphabetical Order:

1.1 No waiting at any time

- (i) Brest Road both sides, for its entirety
- (ii) Colborne Road both sides, from its junction with William Prance Road for its entirety in a southerly, easterly and northerly direction
- (iii) William Prance Road all sides, for its entirety

SCHEDULE OF REVOCATIONS

Items to be revoked from:

- (i) Brest Road west side, for the entire length
- (ii) Brest Road east side, from a point 246 metres south of the junction with Morlaix Drive to the extent of the adopted highway
- (iii) Brest Road east side, from the entrance to Derriford Roundabout to a point 202 metres south of the junction with Morlaix Drive

No waiting at any time

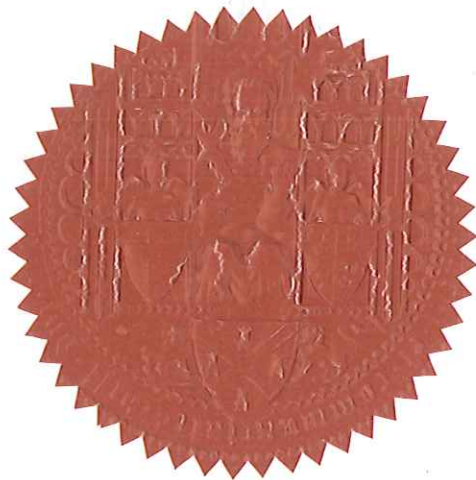
- (i) Brest Road south side, from its junction with William Prance Road to the extent of the adopted highway, a distance of 193 metres in an easterly direction
