THE POOLE (TRAFFIC MANAGEMENT) (REGULATION OF TRAFFIC MOVEMENT AND SPEED LIMITS) (TATNAM ROAD/ST MARGARET'S ROAD) (AMENDMENT NUMBER 60) ORDER 2013

The Council of the Borough and County of the Town of Poole, the Highway Authority in exercise of its power under Section 1(1), 1(3), 1(3A), 2(1), 2(2c), 3(1), 4(1), 4(2), 4(3) and 5, 19, 26, 28, 32, 35, 35A, 36, 47, 49, 53, 63A, 65, 66, 81, 82, 89, 126 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (herein under referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Paragraph 20 of Part III of Schedule 9 to the Act of 1984, hereby makes the following Order:

1. The Poole (Various Roads and Parking Places) (Regulation of Traffic Movement and Speed Limits) (Consolidation of Orders made for the Regulation of On and Off-Street Parking Places) Order No.11 be amended as follows:

A. The following shall be deleted from Schedule No. 1.16 (No Vehicle to Proceed Over Stopped Up Section of Road Except Cyclists) from the Order:

i	St Margaret's Road Rear Service Road	at its western junction with Tatnam Road

B. The following shall be deleted from Schedule No. 8.18 (On Street Parking Place Waiting Limited to Two Hours Mon-Fri 8am-6pm except permit holders (residents) from the Order:

i	Tatnam Road	south side	from a point 26 metres east of its junction with Stanley Green Road	to a point 18 metres north-west of its junction with Wimborne Road

C. The following shall be added to Schedule No. 8.18 (On Street Parking Place Waiting Limited to Two Hours Mon-Fri 8am-6pm except permit holders (residents) to the Order:

i	Tatnam Road	south side	from a point 26 metres east of its junction with Stanley Green Road	to outside No. 1 Tatnam Road
ii	Tatnam Road	south side	from a point 18 metres west of its junction with Wimborne Road	for a distance of 23 metres in a south-westerly direction

2. Save as hereby amended The Poole (Various Roads and Parking Places) (Regulation of Traffic Movement and Speed Limits) (Consolidation of Orders Made for the Regulation of Traffic, On and Off Street Parking Places) Order No. 11 shall remain in full force and effect.
3. This Order shall come into operation on the Eighteenth Day of February of the Year Two Thousand and Fourteen and may be cited as: The Poole (Traffic Management) (Regulation of Traffic Movement and Speed Limits) (Tatnam Road/St Margaret's Road) (Amendment No. 60) Order 2013
