- The manufacturer of the "approved device" may provide a customised version of this declaration, showing the required information, for signature by the principal contact in a traffic authority.
- Where an authority wishes to use a system certified for both bus lane enforcement under the Transport Act 2000 and parking enforcement under the Traffic Management Act 2004, separate declarations for each must be made.
- Once receipt of the declaration has been acknowledged on behalf of the Secretary of State, the authority may use the equipment in accordance with the certification and declaration.
