THE COUNTY OF POWYS (VARIOUS STREETS, YSTRADGYNLAIS) (REVOCATION OF PROHIBITION OF WAITING AND PROHIBITION OF LEFT TURN) ORDER 2014

POWYS COUNTY COUNCIL in exercise of its powers under Sections 1(1) 2(1) and (2) and 4(2) of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

- This Order revokes Powys County Council (Prohibition and Restriction of Waiting and Loading and Parking Places) (Civil Enforcement and Consolidation) Order 2011 on the lengths of roads detailed in schedule I below.
- 2. This Order revokes Powys County Council (Heol Glantawe and Clayphon Bridge/Pantyffynnon Road, Ystradgynlais) (Prohibition of Waiting and Prohibition of Left Turn) Order 2006 on the length of road detailed in schedule II below
- This Order shall come into operation on the 14th day of February 2014 and may be cited as
 The County of Powys (Various Streets, Ystradgynlais) (Revocation of Prohibition of
 Waiting and Prohibition of Left Turn) Order 2014.
- 4. The plan annexed hereto is for the purposes of identification only.

SCHEDULE I

Revocation of Prohibition of Waiting

Lengths of Roads in the Town of Ystradgynlais

- (i) Heol Glantawe(County Classified Road Number U0402) on the east side thereof that extends from a point adjacent to the eastern abutment of Clayphon Bridge in a southerly direction for a distance of 51 metres.
- (ii) Heol Glantawe(County Classified Road Number U0402) on the west side thereof that extends from a point near the south side of Number 1 Pantyffynnon Road in a southerly direction for a distance of 45 metres


