(KATESGROVE ZONE O) (SPECIAL PARKING AREA)

(WAITING RESTRICTIONS AND PARKING PLACES) (MODIFICATION TO EXPERIMENTAL) ORDER 2005

The Reading Borough Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Section 10(2) to the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and of all other powers thereunto enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and the Road Traffic Act 1991, hereby make the following Order:-

1. This Order may be cited as The Borough of Reading (Katesgrove Zone O) (Special Parking Area) (Waiting Restrictions and Parking Places) (Modification to Experimental) Order 2005 and shall come into operation on the 25th January 2005
2. The Borough of Reading (Katesgrove Zone O)(Special Parking Area)(Waiting Restrictions and Parking Places) (Experimental)(No. 2) Order 2004 shall be modified as follows :
 - (i) Item 6 in Schedule 25 shall be modified to read:

" (6) Temple Place, East Side
From a point 13 metres north of its junction with Berkeley Avenue to a point 139 metres north of that junction. "
 - (ii) The following item shall be added to Schedule 99:

" (9) Temple Place, East Side
From a point 131 metres north of its junction with Berkeley Avenue to a point 168 metres north of that junction. "
3. The Borough of Reading (Katesgrove Zone O)(Special Parking Area) (Waiting Restrictions and Parking Places)(Experimental)(No. 3) Order 2004 shall be modified as follows:
 - (i) Article 8 (c) shall include the number of Schedule 44.
 - (ii) Article 14 (1) shall be modified to read:

" 14.(1) The lengths of roads specified in Schedule 44 are authorised to be used :

 - (b) as parking places for the parking during the permitted hours as are specified in the said Schedule, of a vehicle displaying in the relevant position a valid Residents Parking Permit issued by the Council AND
 - (b) for vehicles to wait between 8.00 a.m. and 8.00 p.m. on Mondays to Sundays inclusive for a period of 2 hours excepting if a period of less than 2 hours has elapsed since the previous period of waiting by the same vehicle in the same length of road."

(iii) Article 23 (5) (a) shall include the number of Schedule 44.

(iv) Schedule 49 shall be deleted in its entirety.

(v) Schedule 44 shall be added as follows:

SCHEDULE 44

Shared Use

(A) Permit Holders Only - (Monday to Sunday, 24 Hours)

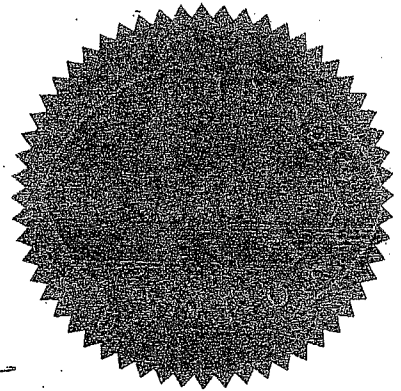


**(B) 2 Hours Limited Waiting, No Return within 2 Hours, Monday to Sunday
8.00am to 8.00pm**

- (10) **Highgrove Street, North Side**
From a point 13 metres east of its junction with Mount Pleasant to a point 58 metres east of that junction.
- (11) **Highgrove Street, South Side**
From a point 14 metres east of its junction with Mount Pleasant to point 56 metres east of that junction.
- (12) **Milman Road, North Side**
From a point 17 metres west of its junction with Whitley Street to a point 38 metres west of that junction.
- (13) **Milman Road, South Side**
From a point 17 metres west of its junction with Basingstoke Road to a point 33 metres west of that junction.
