## PART I CITATION AND INTERPRETATION

- This Order may be cited as The Borough of Reading (Eldon Road Zone I)(Special Parking Areas) (Waiting Restrictions and Parking Places) Consolidation Amendment Order 2007 and shall come into operation on the 17 September 2007.
- The Borough of Reading (Eldon Road Zone I) (Special Parking Area) (Waiting Restrictions and Parking Places) Consolidation Order 2006 shall be amended as follows:
  - i) Items 105, Sidmouth Street, west side and item 106, The Grove, north side are hereby removed from Schedule 28 and inserted into Schedule 44 in their entirety.
  - ii) The following item shall be added to Schedule 99
  - (157) The Grove, north side From a point 48 metres west of its junction with Watlington Street to a point 85 metres west of that junction.
- Insofar as any provision of this Order conflicts with any provision which is contained in an Order made or having effect as if made under the Act or by or under any other enactment then the provisions of this Order shall prevail.
- 4. The restrictions and prohibitions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act or by or under any other enactment.
