**THE BOROUGH OF READING**

**(STATION ACCESS ROAD) (WAITING RESTRICTIONS)**  
**TRAFFIC REGULATION ORDER 2013**

The Reading Borough Council (hereinafter referred to as "The Council"), pursuant to its powers under Sections 1(1), 2(1) to (3), 4(1) and Part IV of schedule 9 to The Road Traffic Regulation Act 1984 (The Act of 1984) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order :

1. This Order may be cited as The Borough of Reading (Station Access Road) (Waiting Restrictions) Traffic Regulation Order 2013 and shall come into operation on 8 July 2013

**PART I**  
**GENERAL**

2. Definitions

In this Order:-

"Bus" has the same meaning as in Regulation 22 of the Traffic Signs Regulations and General Directions 2002;

"Bus Lane" has the same meaning as in Regulation 23 of the Traffic Signs and General Directions 2002 (which also includes sign nos. 953, 958, 959 or approved variants);

"Cycle" means bicycle, tricycle or cycle having four or more wheels, not being in any case a motor vehicle;

"Civil Enforcement Officer" has the same meaning as in section 76 of the Act of 2004;

"Disabled person's badge", "disabled person's vehicle" and "parking disc" have the same meanings as in the Local Authorities Traffic Orders (Exemption for Disabled Persons) (England) Regulations 2000;

"Hackney Carriage" means a vehicle licensed under Section 37 of the Town Police Clauses Act 1847, Section 6 of the Metropolitan Carriage Act 1869 or any similar enactment;

"Loading" means the active loading or unloading of goods to or from a vehicle;

"Relevant position" in respect of:-

- (a) a parking permit, means
  - (i) in the case of a vehicle fitted with a front windscreen, that the badge or permit is exhibited thereon with the front

- facing forward on the nearside of and immediately behind the windscreen; or
- (ii) the case of a vehicle not fitted with a front windscreen, that the badge or permit is exhibited on the front or nearside of the vehicle;
  - (iii) a disabled person's badge, in accordance with Section 12 of The disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;

"Telegraphic Line" has the same meaning as in the Telecommunications Act, 1984;

"The 2002 Regulations" means the Traffic Signs Regulations and General Directions 2002;

"Traffic Sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under Section 64 of the Act of 1984;

## PART II WAITING RESTRICTIONS

3. Save as provided in Article 7 no person shall, except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer, cause or permit any vehicle during each separately dated day to wait or load at any time on Mondays to Sundays inclusive in the lengths of roads specified in Schedule 1.
4. Save as provided in Articles 7 and 8 no person shall, except upon the direction of a police constable in uniform or a Civil Enforcement Officer cause or permit any vehicle except a hackney carriage during each separately dated day to wait at any time on Mondays to Sundays inclusive in the lengths of roads specified in Schedule 2.
5. Save as provided in Article 8(2), no person shall, except upon the direction of or with the permission of a police constable in uniform or a Civil Enforcement Officer cause or permit any vehicle other than a goods vehicle to wait for the purpose of loading in the area of carriageway as specified in Schedule 3 at any time on Mondays to Sundays inclusive.
6. Save as provided in Article 7 no person shall, except upon the direction of or with the permission of a police constable or a Civil Enforcement Officer cause or permit any vehicle to proceed along the lengths of road as specified in Schedule 4.
7. Nothing in Articles 3, 4 and 6 shall apply to any vehicle waiting in the lengths of roads referred to therein for so long as it may be necessary to enable:-
  - (a) a person to board or alight from the vehicle;

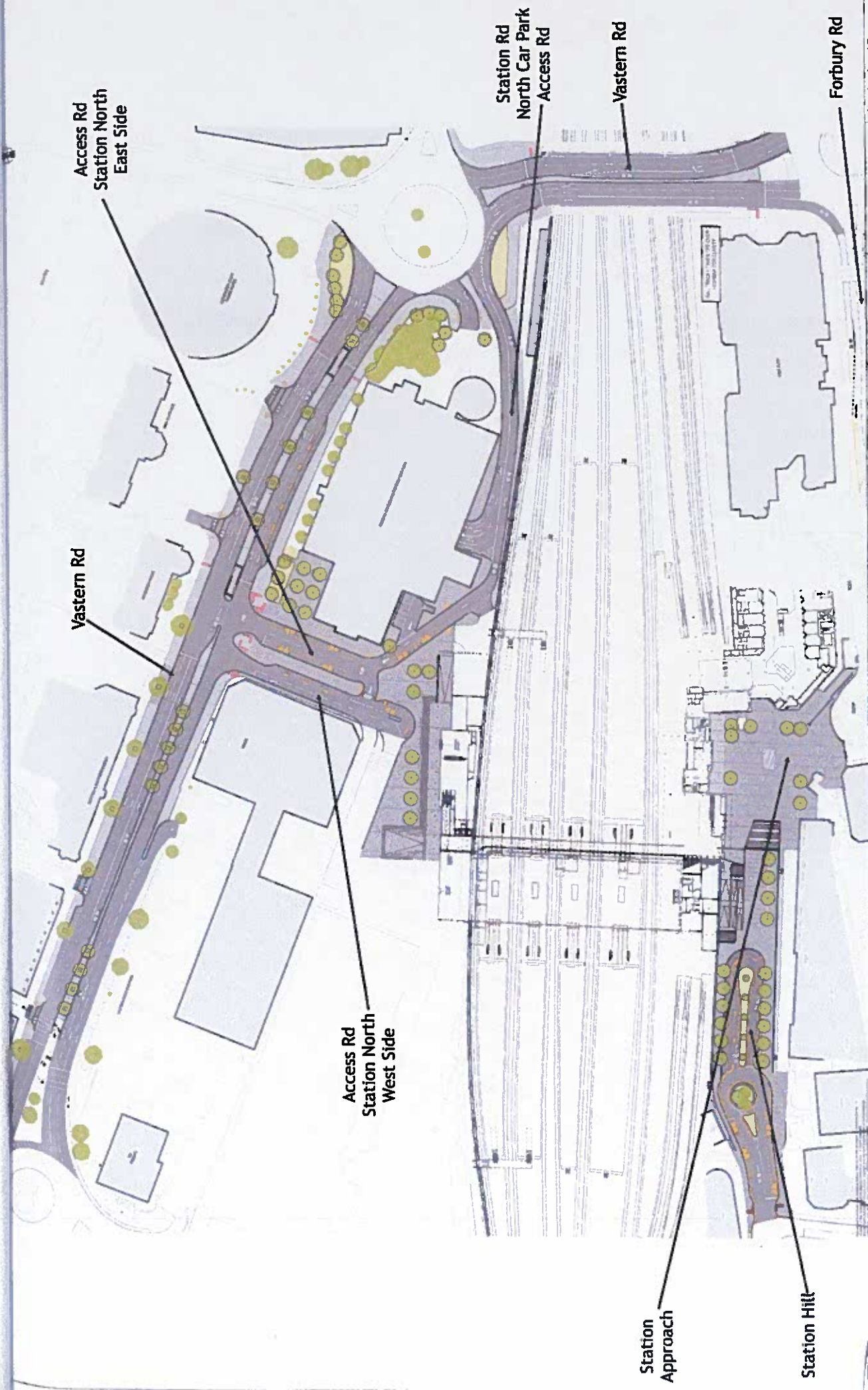
- (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
- (i) building, industrial or demolition operations;
  - (ii) the removal of any obstruction to traffic;
  - (iii) the maintenance, improvement or reconstruction of the said lengths of roads;
  - (iv) the laying, erection, alteration or repair in or in land adjacent to the said lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications system;
  - (v) the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
- (c) the vehicle to be used for the purpose of delivering or collecting postal packages;
- (d) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said lengths of roads;
- (e) the vehicle to wait at or near to any premises situated on or adjacent to the said lengths of roads for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral;
- (f) the vehicle being used for fire brigade, ambulance or police purposes.
8. (1) Nothing in Article 4 shall apply to a Disabled Person's Vehicle, displaying a Disabled Person's Badge in accordance with Section 12 of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000;
- (2) Nothing in Articles 4 and 5 shall apply to any vehicle waiting for so long as may be necessary to enable the vehicle to be used in the provision of a local service within the meaning of the Transport Act 1985.

- 1      No Waiting At Any Time**
- 2      No Waiting At Any Time Except for Hackney Carriages**
- 3      Loading Only**
- 4      Pedestrian Zone, Prohibition of Motor Vehicles**



**SCHEDULE 1**  
**NO WAITING AND NO LOADING AT ANY TIME**

- (1) **Access Road (Station North), West Section, West Side**  
From its junction with Vastern Road for the duration of the western kerb side.
- (2) **Access Road (Station North), West Section, East Side**  
From its junction with Vastern Road to a point 15 metres south of that junction
- (3) **Access Road (Station North), West Section, East Side**  
From a point 35 metres south of its junction with Vastern Road to a point 50 metres south of its junction with Vastern Road
- (4) **Station Hill, North Side**  
From its junction with Greyfriars Road to a point 15 metres east of that junction
- (5) **Station Hill, North Side**  
From a point 35 metres east of the junction of Greyfriars Road to a point 15 metres west of that point.
- (6) **Station Hill, South Side**  
From a point 35 metres east of the junction of Greyfriars Road to a point 20 metres west of that point.
- (7) **Station Hill, South Side**  
From a point 75 metres east of the junction of Greyfriars Road to a point 10 metres west of that point.
- (8) **Station Hill, Central Islands**  
For the kerb line duration around the central traffic islands.

**SCHEDULE 2**  
**NO WAITING AT ANY TIME EXCEPT HACKNEY CARRIAGES**

- (9) **Vastern Road, South Side adjacent to Station multi-storey car park**  
From a point 30 metres east of its junction with Access Road (Station North), East Section for a distance of 130 metres from that point.
- (10) **Access Road (Station North), West Section, East Side**  
From a point 15 metres south of its junction with Vastern Road to a point 35 metres south of its junction with Vastern Road.
- (11) **Access Road (Station North), West Section, East Side**  
From a point 50 metres south of its junction with Vastern Road for a distance of 30 metres.
- (12) **Station Hill, North, East and South Side**  
On the north side from a point 50 metres east of its junction with Greyfrairs Road around the east side of Station Hill and onto the south side

of Station Hill, finishing at a point 80 metres east of its junction with Greyfriars Road on the south side.

**SCHEDULE 3**  
**LOADING ONLY**

- (13) **Station Hill, South Side**  
From a point 55 metres east of its junction with Greyfriars Road for a distance of 25 metres

**SCHEDULE 4**  
**PEDESTRIAN ZONE, PROHIBITION OF MOTOR VEHICLES**

- (14) For the duration of Station Approach to Station Hill.
