**THE BOROUGH OF READING**  
**(STATION ACCESS ROAD) (MOVEMENT CONTROL)**  
**TRAFFIC REGULATION ORDER 2013**

The Reading Borough Council (hereinafter referred to as "The Council"), pursuant to its powers under Sections 1(1), 2(1) to (3), 4(1) and Part IV of schedule 9 to The Road Traffic Regulation Act 1984 (The Act of 1984) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order :

1. This Order may be cited as The Borough of Reading (Station Access Road) (Movement Control) Traffic Regulation Order 2013 and shall come into operation on 8 July 2013

**PART I**  
**GENERAL**

2. Definitions

In this Order:-

"Bus" has the same meaning as in Regulation 22 of the Traffic Signs Regulations and General Directions 2002;

"Bus Lane" has the same meaning as in Regulation 23 of the Traffic Signs and General Directions 2002 (which also includes sign nos. 953, 958, 959 or approved variants);

"Civil Enforcement Officer" has the same meaning as in section 76 of the Act of 2004;

"Cycle" means bicycle, tricycle or cycle having four or more wheels, not being in any case a motor vehicle;

"Hackney Carriage" means a vehicle licensed under Section 37 of the Town Police Clauses Act 1847, Section 6 of the Metropolitan Carriage Act 1869 or any similar enactment;

"Penalty Charge" and "reduced penalty charge" means a charge set by the Council under the provisions of The Bus Lane Contraventions (Penalty Charges, Adjudication and Enforcement) (England) Regulations 2005 and with the approval of the Secretary of State for Transport which is to be paid to the Council within 28 days beginning with the date of the notice, or 14 days in the case of a reduced penalty charge, following the issue of a penalty charge notice;

"Penalty Charge Notice" means a notice issued or served by the Council pursuant to the provisions of regulation 8(1) of The Bus Lane Contraventions (Penalty Charges, Adjudication and Enforcement) (England) Regulations 2005;

"Telegraphic Line" has the same meaning as in the Telecommunications Act, 1984;

"The 2002 Regulations" means the Traffic Signs Regulations and General Directions 2002;

"Traffic Sign" means a sign of any size, colour and type prescribed or authorised under, or having effect as though prescribed or authorised under Section 64 of the Act of 1984;

## **PART II** **PROHIBITED MOVEMENTS**

3. No person shall, except upon the direction or with the permission of a police constable in uniform or of a Civil Enforcement Officer, use a vehicle or cause or permit any vehicle except a Bus, Cycle or Hackney Carriage to be used in the bus lane as specified in Schedule 1
4. Save as provided in Article 5 no person shall except upon the direction or with the permission of a police constable in uniform or a Civil Enforcement Officer, cause or permit any motor vehicle to proceed in the lengths of roads as detailed in columns 1 and 2 of Schedule 2.
5. Nothing in Article 4 shall render it unlawful for a person to cause or permit any vehicle to enter the restrictions if the vehicle is being used for the purpose of:-
  - i) actively loading or unloading, or;
  - ii) for off street access.
6. Save as provided in Article 7, no person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer use a vehicle or cause or permit any vehicle except a bus to be used in the bus lane as specified in Schedule 3.
7. Nothing in Article 6 shall prevent any person causing or permitting any vehicle:-
  - (a) in the service of any local authority or water authority in pursuance of statutory powers or duties to be in the bus lane;
  - (b) which is to be used in connection with the maintenance, improvement or reconstruction of any lengths or road, or the laying, erection, alteration or repair in or near any of the lengths of road of any sewer or main, pipe or apparatus for the supply of gas, water, electricity or telegraph line to be in the bus lane;
8. No person shall cause any vehicle except buses to proceeding along a road specified in column 1 of Schedule 4 to make a right hand turn in to the road as specified in column 2 of the said Schedule in the direction as specified in column 3.

9. No person shall cause any vehicle proceeding along a road specified in column 1 of Schedule 5 to make a right hand turn in to the road as specified in column 2 of the said Schedule in the direction as specified in column 3.
10. No person shall cause or permit any vehicle to proceed along the road as specified in Schedule 6 columns 2 and 3 to make a U turn in the direction as specified in column 3 of the said schedule.
11. No person shall cause any vehicle to proceed in the road as detailed in column 1 and the length of roads as specified in column 2 of Schedule 7 in a direction other than that specified in column 3 in relation to that length of roads as specified in column 1 and 2.

**PART III**  
**CONTRAVENTION OF ORDER**

12. If a vehicle is in an area of road which is or forms part of a bus lane in contravention of any provision of this Order, a penalty charge shall be payable pursuant to Section 144 of the Transport Act 2000.
13. In the case of a vehicle in respect of which a penalty charge is payable, a penalty charge notice showing the information required by section 8 (5) of the Bus Lane Contraventions (Penalty Charges, Adjudication and Enforcement)(England) Regulations 2005 may then be issued by the Council in accordance with section 8(2) and (5) of the said Regulations

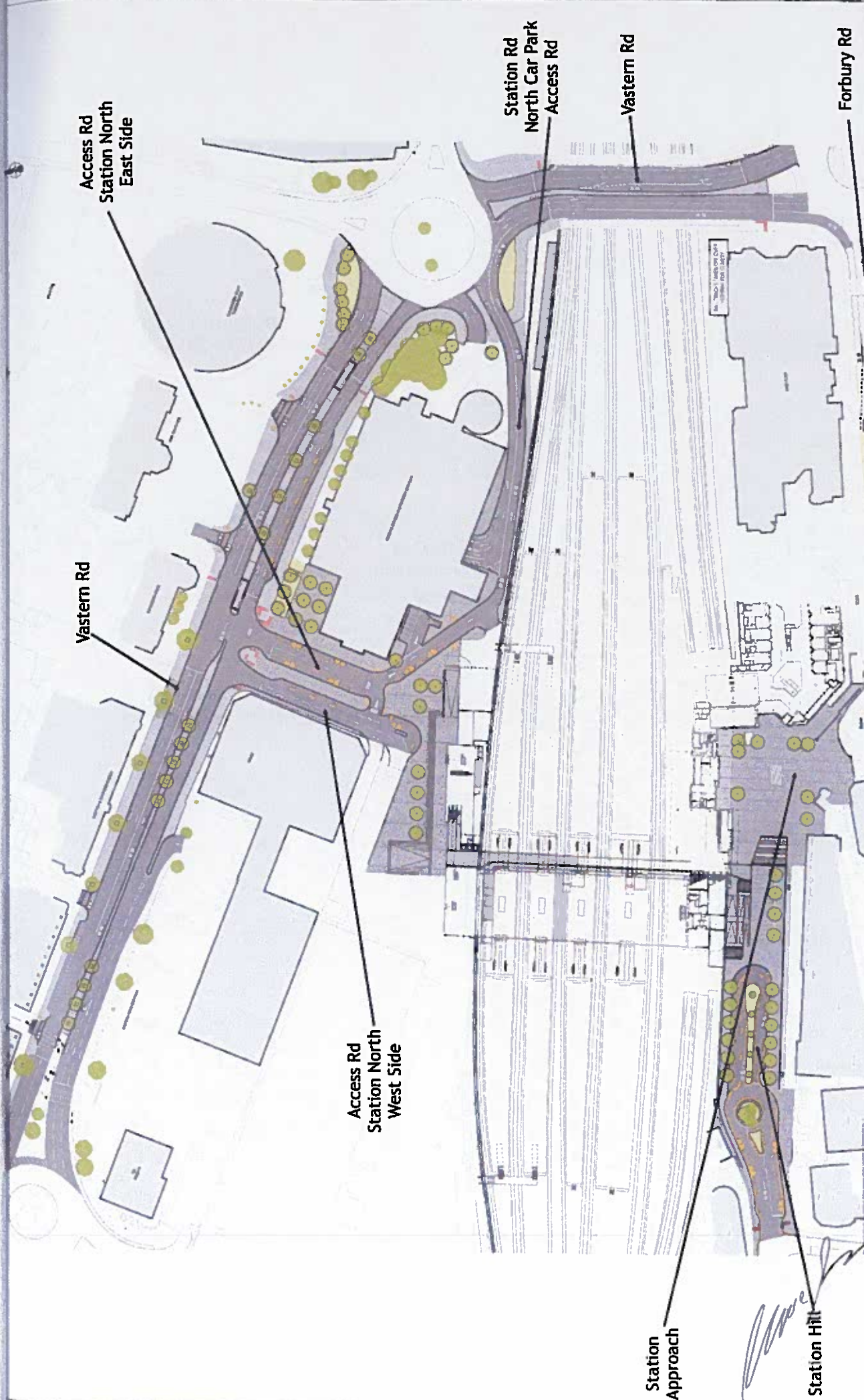

**BUS, CYCLE AND HACKNEY CARRIAGE LANE**

	Column 1 Location	Column 2 Description	Column 3 Direction
(1)	Vastern Road (North Side)	The area of carriageway of that length of Vastern Road which extends from a point 10 metres east of its junction with De Montfort Road to a point 40 metres west of its junction with George Street	West to East, (With Flow) Offside Lane
(2)	Forbury Road (North Side) Vastern Road (West Side) & Station Car Park Access Road (South Side)	The area of carriageway which extends from a point 35 metres east of the Apex Plaza Service Road junction and continues along the kerb line for the duration of Forbury Road, Vastern Road West Side and along the south side of Station Car Park Access Road.	(With Flow)
(3)	Vastern Road (East Side)	The area of carriageway of that length of Vastern Road which extends from a point 40 metres south of its junction with Napier Road to a point 60 metres south of that point	North to South, (With Flow) Offside Lane
