THE BOROUGH OF READING (KENNET ISLAND BUS GATE) (STATION ACCESS ROAD) (AMENDMENT) ORDER 2015

The Reading Borough Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1(1), 2(1) to (3), 4(2), of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and of all other powers thereunto enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

PART I CITATION AND INTERPRETATION

- 1. This Order may be cited as The Borough of Reading (Kennet Island Bus Gate) (Station Access Road) (Amendment) Order 2015 and shall come into operation on the 12 November 2015.
- The prohibitions imposed by this Order shall be in addition to and not in derogation of any restriction, prohibition or requirement imposed by any Regulations or Orders made or having effect as if made under the Act of 1984, or by or under any other enactment.
- 3. Save where the contrary is indicated, any reference in this Order to:-
 - (a) a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order;
 - (b) this Order or another Order shall be construed as such a reference to this Order or, as the case may be, such other Order, as the same may have been or may from time to time be amended, varied or supplemented;
 - (c) a Statute or Regulation shall be construed as reference to such Statute or Regulations as the same may have been, or may from time to time be amended or re-enacted.
 - (d) The requirements of any Article making reference to a numbered Schedule to this Order shall only have effect when a Schedule similarly numbered is appended to this Order.

PART II REVOCATION AND AMENDMENT OF ORDERS

4. The Borough of Reading (Kennet Island) (Bus Gate) Order 2013 Schedule shall be revoked and replaced with the following Schedule:

SCHEDULE PROHIBITION OF VEHICLES EXCEPT BUSES AND CYCLES

(1) Lindisfarne Way, westbound From a point 41.5m east of its junction with Whale Avenue

(2) Lindisfarne Way, eastbound From a point 3.5m west of its junction with Havergate Way

5. The Borough of Reading (Station Access) (Movement Control) Traffic Regulation Order, 2013 Schedules: 1 - Bus and Hackney Carriage Lane, 2 - Prohibition of Motor Vehicles, except bus, cycle, hackney carriage and loading to off street access, 3 - Bus Only, 4 - No right Turn, 5 - No Right Turn and 7 - One Way Traffic shall be revoked and replaced with the following Schedules:
