### THE BOROUGH OF READING (EAST READING) (RED ROUTE AND WAITING RESTRICTIONS) ORDER 2025

The Reading Borough Council (hereinafter referred to as "The Council"), pursuant to its powers under Sections 1, 2, 3, 4, 32, 35, 45 and 46 to The Road Traffic Regulation Act 1984 (The Act of 1984) and Part IV of Schedule 9 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

#### <u>PART I</u>

#### 1. COMMENCEMENT AND CITATION

- 1.1. This Order may be cited as "The Borough of Reading (East Reading) (Red Route and Waiting Restrictions) Order 2025".
- 1.2. This Order shall come into operation on 3 February 2025.

#### 2. **DEFINITIONS**

#### 3. INTERPRETATION

3.1. The making of this Order by the Council is done so under the duty imposed by Section 122(1) of the 1984 Act to secure the expeditious, convenient, and safe movement of vehicular and other traffic and the provision of suitable and adequate parking facilities on and off the highway, insofar as practicable having regard to the matters in Section 122(2) of the 1984 Act.

- 3.2. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the 1984 Act or by or under any other Enactment provided that where a prohibition or restriction which is imposed, varied or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail.
- 3.3. The Interpretation Act 1978 (as amended) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3.4. Any reference to a numbered article shall, unless the context requires otherwise, be construed as a reference to the article bearing that number in this Order.
- 3.5. Words importing the masculine gender shall also include the feminine gender and words in the singular include the plural and vice versa.
- 3.6. Headings are inserted for ease of reference only and shall not affect the construction or interpretation of this Order.
- 3.7. In the event this Order contains errors which renders any provision of it void or unenforceable, all other provisions of this Order shall continue to have effect.
- 3.8. Any reference in this Order to a Permit shall, unless otherwise stated, refer to a Permit to park in the lengths of Roads specified in Schedules 8 and 9 and shall be a Virtual Permit issued through the Council's Virtual Permit System.
- 3.9. The plans annexed to this Order identifies the lengths of Roads subject of this Order, provided that where there is any inconsistency between the plans and the Schedules it is the wording of the Schedules that shall prevail.

#### PART II PROHIBITIONS AND RESTRICTIONS

#### 4. WAITING, LOADING AND UNLOADING

- 4.1. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit any Vehicle to Wait At Any Time in the lengths or parts of the Roads specified in Schedule 1 of this Order.
- 4.2. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit any Vehicle to Wait or Load At Any Time in the lengths or parts of the Roads specified in Schedule 2 of this Order.
- 4.3. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit any Vehicle to Wait At Any Time or Load during each separately dated day, Monday to Saturday in the lengths or parts of the Roads specified in Schedule 3 of this Order.
- 4.4. No person shall, except upon the direction or with the permission of a Police Constable in uniform

or a Civil Enforcement Officer, cause or permit any Vehicle to Wait At Any Time or Load from 8.15am - 9.15am and again from 4pm-6.15pm in the lengths or parts of the Roads specified in Schedule 4 of this Order.

#### 5. STOPPING

- 5.1. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit the use of any Vehicle to Stop At Any Time in the lengths or parts of the Red Route specified in Schedule 5 of this Order.
- 5.2. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit any Vehicle to Stop during each separately dated day, Monday to Saturday from 7am to 7pm except for Loading or Unloading only from 10am 4pm with a maximum stay of 20 minutes, in the lengths or parts of the Red Route specified in Schedule 6 of this Order.
- 5.3. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit any Vehicle to Stop At Any Time except for Loading or Unloading only, with a maximum stay of 20 minutes, in the lengths or parts of the Red Route specified in Schedule 7 of this Order.
- 5.4. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit any Vehicle, to Stop in the lengths or parts of the Red Route specified in Schedule 8 of this Order except for Permit Holders only of Zone 14R or for Pay and Display users.
- 5.5. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer, cause or permit any Vehicle to stop in the lengths or parts of the Red Route specified in Schedule 9 of this Order, except from 8am-8pm when Stopping is Permitted for use by Zone11R Permit Holders or for a maximum stay of 2 hours with no return within 30 minutes for non Permit Holders. At all other times, Stopping is restricted to Permit Holders only.
- 5.6. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer cause or permit a Vehicle to Stop on any Footway, Verge or Central Reservation along the Red Route or within the Red Route Area.

#### PART III GENERAL EXEMPTIONS OF THIS ORDER

#### Exemptions to the Waiting Loading and Unloading provisions of this Order

- 6. Nothing in Articles 4 of this Order shall render it unlawful to cause or permit any Vehicle to Wait during the controlled hours for the lengths of Roads or on any of the sides of Roads referred to therein, or in any part of a Parking Place, if the use of that part has not been suspended, for a period no longer than is necessary for: -
- 6.1. a person to Board or Alight from the Vehicle;
- 6.2. the vehicle is an Authorised Vehicle;
- 6.3. the closing of any gate or other barrier at the entrance of premises to or from which the Vehicle

is gaining or has gained access or egress;

- 6.4. the Vehicle, if it cannot conveniently be used for such purpose in any other Road, to be used in connection with any of the following operations, namely
  - 6.4.1. building, industrial, demolition or excavation operations;
  - 6.4.2. the removal of any obstruction to traffic;
  - 6.4.3. the maintenance, improvement or reconstruction of the said lengths of Road or Road;
  - 6.4.4. the laying, erection, installation, alteration, removal or repair in or in land adjacent to the said lengths of Road or sides of Road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any Electronic Communications Apparatus;
  - 6.4.5. the construction, installation, improvement, maintenance, repair or cleaning of any Traffic Sign, bus stop infrastructure or other street furniture or other object lawfully placed or to be placed on, in or over the said lengths of Roads or sides of Roads;
- 6.5. a Liveried Vehicle to be used for fire and rescue, Ambulance purposes or for the purpose of providing a response to an emergency at the request of an NHS ambulance service, Blood Service, police, bomb or explosive disposal, Special Forces, Armed Forces and National Crime Agency purposes;
- 6.6. preventing a Vehicle from proceeding by any circumstances beyond their control, where the said circumstance relates directly to the movement, or otherwise of traffic on the Road;
- 6.7. avoiding an accident;
- 6.8. the Vehicle, if it cannot conveniently be used for such purpose in any other Road, to be used in the service of a local authority, the Environment Agency, a water undertaker or sewerage undertaker in pursuance of statutory powers or duties;
- 6.9. a Vehicle is a Royal Mail Liveried Vehicle or is one in the service of a Universal Service Provider:(a) Delivering or Collecting or Loading or Unloading Postal Packets to or from addresses or public letter boxes in or adjacent to the Road in which the Vehicle is Waiting or (b) servicing a telephone kiosk adjacent to the Road in which the Vehicle is Waiting;
- 6.10. the Vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said lengths of Road or sides of Road;
- 6.11. as long as is reasonably necessary for the official wedding car(s) or an official Hearse and any other Motor Vehicle provided by the funeral director to Wait at or near to any premises situated on or adjacent to any length of Road for the purpose of a wedding or funeral provided that the Vehicle can be reasonably be used for that purpose only from that Road;
- 6.12. the Vehicle is being used for purposes of a local authority in pursuance of statutory power duties if it cannot conveniently be used for such purpose in any other Road;
- 6.13. a Vehicle being a recovery Vehicle and is Waiting to enable it to be used in connection with the removal of a traffic obstruction or a Vehicle which has broken down;
- 6.14. Nothing in Article 4.1 of this Order shall render it unlawful to cause or Permit a Disabled Person's Vehicle which displays in the Relevant Position a Disabled Person's Badge and Parking Disc (on which the Driver, or other person in charge of the Vehicle, has marked the time at which the period

of Waiting began) to Wait in any of the lengths of Road or on any of the sides of Road referred to therein for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of Waiting by the same Vehicle in the same length or on the same side of Road on the same day).

7. Nothing in Article 4 of this Order shall render it unlawful to cause or permit any Vehicle to Wait for so long as may be necessary and in any event for no longer than 20 minutes for the purpose of enabling goods to be Loaded and/or Unloaded from the vehicle provided that such exemption does not apply during the hours when loading/unloading restrictions are imposed by that Article.

#### **Exemptions Stopping Restrictions**

- 8. Nothing in Article 5 shall apply any person from causing or permitting any Vehicle to stop in the lengths of Red Route or on the sides of the Red Route in the Red Route area referred to therein so long as may be necessary if that person is:
  - 9.1 required by law to cause the Vehicle to stop or not to proceed.
  - 9.2 obliged to stop the Vehicle so as to avoid an accident.
  - 9.3 prevented from proceeding by any circumstances beyond their control, where the said circumstance relates directly to the movement, or otherwise of traffic on the Red Route;
  - 9.4 getting or giving help in consequence of an accident or an emergency or otherwise taking action for public safety.
  - 9.5 opening of closing a gate or other barrier at the entrance to premises to which the Vehicle is being driven or from which it has emerged if it is not reasonably practicable to cause the Vehicle to stop elsewhere for the purpose.
  - 9.6 using a Liveried Vehicle for fire and rescue, Ambulance, providing a response to an emergency at the request of an NHS ambulance service, police, bomb or explosive disposal, Special Forces, and National Crime Agency purposes.
  - 9.7 using a Vehicle in connection with the removal of any obstruction to traffic.
  - 9.8 using a Vehicle for the purposes of maintenance, improvement or reconstruction of the said lengths of any part of the Red Route or the Red Route Area.
  - 9.9 using a Disabled Person's Vehicle which displays a disabled person's badge in the Relevant Position to stop for so long only as may be required to enable a disabled person Board or Alight the Vehicle.
  - 9.10 using a Vehicle in the service of a local authority, the Environment Agency, a water undertaker or sewerage undertaker in pursuance of statutory powers or duties.
  - 9.11 the laying, erection, alteration, repair or cleaning in or near the controlled area of any sewer, or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any Electronic Communications Apparatus kept installed for the purposes of an electronic communications code system or of any other Electronic Communications Apparatus lawfully kept installed in any position;
  - 9.12 doing anything done with the permission or at the direction of a police constable in uniform or a Civil Enforcement Officer;
  - 9.13 Using a Pedal Cycle;
  - 9.14 an Authorised Vehicle.
- **9.** Nothing in Article 5 shall apply any person from causing or permitting a Hackney Carriage, a Licensed Private Hire Vehicle to stop except for so long only as may be required to enable Waiting passenger(s) to Board or Alight the Vehicle.

**10.** Nothing in Article 5 of this Order shall render it unlawful to cause or permit a Bus to stop within a Red Route Bus Stop Clearway for as long as may be required to enable passengers to Board or Alight; or (ii) a Bus in the provision of a local service to stop within an area within the Red Route if it is being used for Operational Reasons or training Drivers to allow such a service to be provided.

#### PART IV AUTHORISATION AND USE OF PARKING PLACE

- **11.** The lengths of Roads specified in Schedules 8 and 9 are authorised to be used as Parking Places by Vehicles of such classes of Vehicle, in such positions, on such days and within such Permitted Hours/time limits as specified.
- **12.** Where in Schedules 8 and 9 a Parking Place is described as available for Vehicles of a specific class or in a Specified Position, the Driver of a Vehicle shall not permit it to Wait in the Parking Place unless it: -
  - (a) is of the specified class; or as the case may be -
  - (b) is in the Specified Position;
  - (c) displays a valid Permit issued by the Council.
- **13.** A Driver of a Vehicle shall not use a Parking Place so as to unreasonably prevent access to any premises adjoining the Road, or the use of the Road by any other person, or so as to be a nuisance.
- **14.** A Driver of a Vehicle shall not use a Parking Place when a Police Constable in uniform, a Civil Enforcement Officer or a person authorised by the Council has closed the Parking Place.
- **15.** The Driver of a motor Vehicle using a Parking Place shall stop the engine as soon as the Vehicle is in position in the Parking Place and shall not start the engine except when about to change the position of the Vehicle in, or to depart from, that Parking Place.
- **16.** No person shall use a Vehicle whilst it is in a Parking Place in connection with the sale or offering or exposing for sale any article to persons in or near the Parking Place, or in connection with the sale or offering for hire any skill or services.
- **17.** When a Vehicle is left in a Parking Place in contravention of any provision of this Order, a Police Constable in uniform, or a Civil Enforcement Officer or a person authorised by the Council to do so may alter or cause to be altered the position of the Vehicle so that its position shall comply with that provision.
- **18.** Any person altering the position of a Vehicle by virtue of Article 17 may do so in such manner as he thinks necessary.
- **19.** A Police Constable in uniform, or a Civil Enforcement Officer or a person authorised by the Council to do so may, in case of emergency, or in contravention of any provision of this Order, remove or cause to be removed to any place he thinks fit any Vehicle left in a Parking Place.
- **20.** Any person removing or causing to be removed a Vehicle from a Parking Place in accordance with Article 17 shall provide for the safe custody of the Vehicle.

#### PART V

#### AUTHORISATION AND USE OF PAY AND DISPLAY PARKING PLACES

- **21.** The lengths of Roads specified in Schedule 8 are authorised to be used as Pay and Display Parking Places during the Permitted Hours and for such maximum period as specified in Schedule 10 provided the:
  - (a) relevant charge specified in Schedule 10 has been paid in full.
  - (b) Vehicle falls within a class specified in Article 23.
  - (c) Vehicle is displaying in the Relevant Position a valid Permit issued by the Council.
- 22. The Council may: -
  - (a) install, in such position or in the vicinity of a Pay and Display Parking Place as it may think fit, such Pay and Display Ticket Machines for the purposes of that Pay and Display Parking Place; and
  - (b) carry out such other work authorised by this Order or is reasonably required for the purpose of that Pay and Display Parking Place.
- **23.** No person shall except upon the direction or with the permission of a Police Constable in uniform or a Civil Enforcement Officer cause or Permit any Vehicle to be left in a Pay and Display Parking Place as authorised by Article 21, unless it is one of the following specified class of Vehicles:
  - (a) A Vehicle displaying a Disabled Persons Badge
  - (b) Dual Purpose Vehicles
  - (c) Goods Vehicle (which does not exceed 5.30 metres in length or 2.25 metres in height and being less than 3.5 tonnes)
  - (d) Invalid Carriages
  - (e) Motorcycles
  - (f) Motor Tricycles
  - (g) Passenger Vehicle
- **24.** Any Vehicle left in a Pay and Display Parking Place must be parked entirely within the marked limits of the individual Parking Place as specified Schedule 8 of this Order.
- 25. No Vehicle shall display a Parking Ticket which has been previously displayed on another Vehicle.
- **26.** The Parking Charges specified in Schedule 10 of this Order are payable for any Vehicle left in a Parking Place during the Permitted Hours immediately upon that Vehicle being left in that Parking Place as specified in Schedule 8.
- 27. No Vehicle which has been taken away from a Parking Place after the minimum charge had been incurred shall, not return to the Parking Place unless the minimum charge as specified in Schedule 10 is paid again.
- **28.** Where a notice or notices which has been duly authorised by the Council are displayed stating that such a facility for payment of a Parking Charge is available, then the Parking Charge as specified in Schedule 10 of this Order shall be payable by:
  - (a) the insertion of coins of appropriate denominations or Payment Card into a Pay and Display Ticket Machine as provided by Schedule 11 of this Order; or
  - (b) means of a Telephone Payment Parking System; or

- (c) means of an Electronic Payment System.
- **29.** Upon using a Pay and Display Ticket Machine, where more coins than one is required, they shall be inserted in the Pay and Display Ticket Machine immediately one after the other for the appropriate charge.
- **30.** Upon using a Pay and Display Ticket Machine to leave a Vehicle in a Parking Place as specified in Schedule 8 of this Order during the Permitted Hours, the Driver of the said Vehicle shall be required to:
  - a) the registration mark of the Vehicle that has been left in the Parking Place; and
  - b) select the time duration required; and
  - c) pay the relevant Parking Charge.
- **31.** Upon using a Telephone Payment Parking System to leave a Vehicle in any Parking Place as specified in Schedule 8 of this Order, during the Permitted Hours, the Driver of the said Vehicle shall be required to provide the following information:
  - a) the make of the Vehicle that has been left in the Parking Place; and
  - b) the colour of the Vehicle that has been left in the Parking Place; and
  - c) the registration mark of the Vehicle that has been left in the parking place;

d) the location code of the parking place which is identified on the traffic signs within the parking place;

e) the time duration required to leave the Vehicle in the Parking Place.

- **32.** Payments made using a Telephone Payment Parking System or an Electronic Payment System apply only to the Parking Places associated with the provided location identification number.
- **33.** Drivers are responsible for ensuring accurate information is provided through any payment system or Pay and Display Ticket Machine.
- **34.** Upon payment of the appropriate charge for the Vehicle, the Driver shall display on that Vehicle, in accordance with the provisions of Article 35, a Parking Ticket issued by a Pay and Display Ticket Machine.
- 35. The Parking Ticket referred to in Article 34 above shall be displayed on the Vehicle:
  - a) where the Vehicle is fitted with a front glass windscreen extending across the Vehicle to the near side facing forwards on the near side of the glass of such windscreen, behind the glass; or
  - b) where the Vehicle is not fitted with a front glass windscreen on the near side of the Vehicle facing towards the near side of the Road.

but in all cases so that the time shown on the Parking Ticket is clearly visible to a person standing at the kerbside of the Vehicle.

**36.** Displaying a Parking Ticket is not required if payment is made via a Telephone Payment Parking System or an Electronic Payment System and this can be validated through a Handheld Device with an indication of the date and time of expiry of the parking period for which such Parking Charge has been paid.

- 37. If any time while a Vehicle is left in a Pay and Display Parking Place referred to in Schedule 8 of this Order, during the Permitted Hours, and no indication appears on a Hand Held Device that payment of the Parking Charge has been made or an indication that the parking period for which payment was made has expired, it shall be presumed unless the contrary is proved, that either:-
  - (a) the Parking Charge has not been duly paid in respect of that Vehicle; or
  - (b) the parking period for which payment was made has expired;

and the Vehicle may be issued with a Penalty Charge Notice.

- **38.** If at any time when a Vehicle is left during the Permitted Hours in a Pay and Display Parking Place there is on the nearest Pay and Display Ticket Machine a notice placed by any person duly authorised by the Council indicating that the Pay and Display Ticket Machine is out of Order, then a Parking Ticket shall be obtained where possible from another Pay and Display Ticket Machine or by means of an alternative payment method.
- **39.** Any Vehicle that has been left in any Parking Place as specified in Schedule 8 of this Order, during the Permitted Hours, that has not paid the relevant Parking Charge at the Pay and Display Ticket Machine, by a Telephone Payment Parking System or by an Electronic Payment System may be issued a Penalty Charge Notice.
- **40.** The Pay and Display Parking Place may be used without any limit on time, subject to the provision of this Order, for the leaving during the Permitted Hours a Disabled Persons Vehicle displaying a Disabled Person's Badge in accordance with Section 12 of The Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 in the Relevant Position a disabled persons badge, but only if that Vehicle has been or is about to be driven or used by the person to whom the badge has been issued, or as the case may be used for carrying of Disabled Person(s) as passenger(s).

### PART VI <u>PERMITS</u>

- **41.** Subject to Articles 43 and 44 any person at an address listed in Schedule 12 of this Order and being the Owner of a Passenger Vehicle, an Invalid Carriage or a Motorcycle may apply to the Council or an Authorised Agent for the issue of a Permit for the relevant area.
- **42.** Any application for a Permit shall be made online using the Council's Virtual Permit System and shall include the particulars and information as may be required to enable the Council to confirm validity of the application.
- **43.** The Council or Authorised Agent may at any time require an applicant for a Permit or a Permit Holder to produce to an officer of the Council such evidence in respect of an application for a Permit made to them as they may reasonably require to verify any particulars or information given to them or in respect of any Permit issued by them as they may reasonably require to verify that the applicant is entitled to apply or that the Permit is validly issued or being validly used.
- **44.** The Council or Authorised Agent upon being satisfied that the applicant is entitled to apply and who is the Owner of a Vehicle of the class specified in Article 23, shall issue to the applicant a Virtual Permit for use during the Permitted Hours in a Parking Place of the Vehicle to which such Permit relates, by the Owner or by any person using such Vehicle with the consent of the Owner (other than a person to whom such Vehicle has been let for hire and reward).

- **45.** A Permit shall only be a valid for use in a Parking Place specified in Schedules 8 and 9.
- **46.** Notwithstanding the provisions contained within this Order, the Council may also grant a Permit to such other persons as they may think fit.
- **47.** A Permit Holder shall surrender such Permit to the Council or Authorised Agent on the occurrence of any one of the events set out in Article 49.
- **48.** The Council or Authorised Agent may, by notice in writing serve on the Permit Holder at the address shown by that person on the application for the Permit or at any other address believed to be that person's residence, withdrawing a Permit if it appears to the Council or Authorised Agent that any one of the events set out in Article 49 has occurred and the Permit Holder shall surrender the Permit to the Council or Authorised Agent within 48 hours of the receipt of the aforementioned notice.
- 49. The events referred to in the foregoing provisions of this Article are:-
  - (a) the Permit Holder ceasing to be a Resident;
  - (b) the Permit Holder ceasing to be the Owner or Principal User of the Vehicle in respect of which the Permit was issued;
  - (c) the Vehicle in respect of which such Permit was issued being adapted or used in such a manner that it is not a Vehicle of the class specified in Article 23;
  - (d) the issue of a Duplicate Permit by the Council under the provisions of Article 51;
  - (e) the expiry of the period for which the Permit was issued;
  - (f) the Permit Holder otherwise failing to comply with the terms of use of the Permit or failing to satisfy the eligibility criteria for the Permit;
  - (g) the Permit details being tampered with; or
  - (h) where a Permit is issued to any person upon receipt of a cheque and the cheque is subsequently dishonoured, the Permit shall cease to be of any effect.
- **50.** Without prejudice to any of the provisions of this Order, a Permit shall cease to be valid at the expiration of the period specified thereon: -
  - (a) which period, shall not exceed the Permit Payment Period of from the end of the month during which it first became valid; or
  - (b) on the occurrence of any one of the events set out in Article 49, whichever is the earlier.
- **51.** If a Permit is accidentally mutilated or defaced or the figures or particulars thereon have become illegible or the colour of the Permit has become altered by fading or otherwise, the Permit Holder shall surrender it to the Council or Authorised Agent and apply to the Council via it Virtual Permit System or Authorised Agent for the issue of a Duplicate Permit, whereupon Council or Authorised Agent, shall issue a Duplicate Permit so marked and upon such issue the original Permit shall

become invalid.

- **52.** If a Permit is lost or destroyed, the Permit Holder may apply to the Council or Authorised Agent for the issue to him of a Duplicate Permit and the Council or Authorised Agent upon being satisfied as to such loss or destruction, shall issue a Duplicate Permit so marked and upon such issue the lost of destroyed Permit shall become invalid.
- **53.** All the provisions of this Order shall apply to a Duplicate Permit to the same extent as they applied to the original Permit or lost of destroyed Permit.
- **54.** At all times during which a Vehicle is left in a Parking Place specified in Schedules 8 and 9 during the Permitted Hours, it shall be regarded as having purchased a valid Permit, if its system registration details appear on the Civil Enforcement Officer's handheld device or be obtained by a Civil Enforcement Officer contacting the service provider.
- **55.** If at any time while a Vehicle is left in a Parking Place and there is no indication that payment of the charge for a Permit has been made using the Council's Virtual Permit System, or there is an indication that the parking period for which payment was made has expired, it shall be presumed, unless the contrary is proved, that either:
  - a) the Permit has not been duly paid in respect of that Vehicle; or
  - b) the Permit period for which payment was made has expired.

#### 56. Application for Paper Permit

- 56.1. The Council shall consider any application for exemption, in respect of a Permit from the Council's Virtual Permit system for any person complying with the requirements of Article 44 that may, through any valid particular circumstance, be unable to use the Council's Virtual Permit system and upon such application being successful shall, on receipt of the relevant fee issue a Paper Permit.
- 56.2. At all times during which a Vehicle is left in a Permit Parking Place or area during the Permitted Hours the Paper Permit must be continuously displayed so that all details are clearly visible and can be easily seen and read from the outside of the Vehicle, unless the Permit Holder has obtained a Virtual Permit which exempts them from displaying a Permit.
- **57.** When a Permit has been displayed in accordance with the Relevant Position or where a Penalty Charge Notice has been attached to the Vehicle, no person other than a Police Constable in uniform, or a Civil Enforcement Officer shall remove such Permit or notice from the Vehicle unless authorised to do so by the Driver of that Vehicle.
- **58.** Notwithstanding the foregoing provisions of this Order, the Council may at its discretion issue a Permit allowing a specific Vehicle to Wait in a Road or a Parking Place during the hours of operation of any restriction or prohibition to the contrary.

#### PART VII SUSPENSION OF PARKING PLACES

**59.** The Council may by notice of by Order, suspend the use of any Parking Place or any part thereof:

- 59.1. if it is satisfied that the use of that Parking Place should be restricted or prohibited by reason that works are being or are proposed to be executed on or near the Road, or by reason of the likelihood of danger to the public or of serious damage to the highway; or
- 59.2. for the purpose of facilitating the movement of traffic or promoting its safety; or
- 59.3. for preventing obstruction of the streets on the occasion of any public procession, rejoicing or illumination or when the streets are thronged or liable to be obstructed; or
- 59.4. for the purpose of facilitating the movement of traffic or promoting its safety; or
- 59.5. for the convenience of occupiers of premises adjacent to the Parking Place on any occasion of the removal of furniture from one building to another or the removal of furniture from such premises to a depository or to such premises from a depository; or
- 59.6. for the convenience of occupiers of premises adjacent to the Parking Place at the times of weddings, funerals, special events or religious ceremonies;

subject to such conditions or exemptions as they consider necessary.

**60.** A Police Constable in uniform may suspend for no longer than seven days the use of a Parking Place or any part thereof whenever they consider such suspension reasonably necessary, expedient to prevent or mitigate congestion or obstruction of traffic, or danger to or from traffic, in consequence of extraordinary circumstances.

### PART VIII CONTRAVENTION OF THIS ORDER

- **61.** If a Vehicle is left in a prohibited or restricted Road or Parking Place without complying with the requirements of this Order, a contravention shall be deemed to have occurred and Penalty Charge Notice shall be payable for each calendar day or part thereof that the Vehicle is in contravention of this Order, conforming to any relevant statutory requirement may then be served and or the Vehicle may be removed from the location.
- **62.** A Penalty Charge Notice affixed to a Vehicle in accordance with Article 61 above shall not be removed or interfered with except by or under the authority of the owner, or person in charge of the Vehicle or the Council or Authorised Agent.
- **63.** Where a Civil Enforcement Officer has removed or caused to be removed a Vehicle in accordance with Article 61.
  - (a) he/she shall provide for the safe custody of the Vehicle;
  - (b) the Council shall be entitled to recover from the Owner or the person responsible such charges in respect of the removal, storage and disposal of the Vehicle as it might be prescribed from time to time.
  - (c) the provisions of the 1984 Act as amended shall apply to the disposal of such Vehicles removed by or on behalf of the Council pursuant to this Article.

#### PART IX

#### **REVOCATIONS**

**64.** Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, the items contained within the orders specified at Schedule 13 are hereby revoked.
