THE BOROUGH OF READING (CIVIL ENFORCEMENT AREA) (WAITING RESTRICTIONS REVIEW 2022B) ORDER 2023

The Reading Borough Council (hereinafter referred to as "The Council"), pursuant to its powers under Sections 1, 2, 3, 4, 32, 35,45 and 46 to The Road Traffic Regulation Act 1984 (The Act of 1984) and Part IV of Schedule 9 and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:

- 1. This Order may be cited as "The Borough of Reading (Civil Enforcement Area) (Waiting Restrictions Review 2022B) Order 2023"
- 2. The Order shall come into operation on 16 October 2023.

PART I GENERAL AND INTERPRETATION

3. Definitions

In this Order:-

"ambulance"	has the same meaning as in the Vehicle Excise and Registration Act 1994;	
"authorised person"	means an employee or agent of the Council authorised to exercise all or any of the functions of the Council under this Order;

- **4**. (1) Except where otherwise stated, any reference in this Order to a numbered Article is a reference to the Article bearing that number in this Order;
 - (2) Any reference in this Order to any enactment shall be construed as a reference to that enactment as amended by any subsequent enactment:
 - (3) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment provided that where a prohibition or restriction which is imposed, varied or revoked by this Order is in conflict with a prohibition or restriction imposed by a previous Order, then the provision of this Order shall prevail;
 - (4) The Interpretation Act 1978 (as amended) shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament;
 - (5) Nothing in this order shall prevent the Council from suspending any of the restrictions within this order.

PART II PROHIBITION OF STOPPING

- 5. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a civil enforcement officer, cause or permit any vehicle during each separately dated day, to:-
 - stop at any time except for loading or unloading only, with a maximum stay 40 minutes in the length of the Red Route as specified in Schedule 1;
 - stop except loading or unloading only, from 9pm-5am, with a maximum stay 40 minutes in the length of the Red Route as specified in Schedule 2;
 - stop between 11pm-5am except taxis and between 5am-11pm except for loading or unloading, for a maximum stay of 40 minutes in the length of the Red Route as specified in Schedule 3;
 - stop a vehicle except goods vehicle loading or unloading only with a maximum stay of 20 minutes in the length of the Red Route as specified in Schedule 5;
 - stop at any time except motorcycles in the length of the Red Route as specified in Schedule 6:
 - stop Monday Friday 8am-5pm on school entrance markings in the length of road specified in Schedule 8;
 - stop except for parking at any time in the length of the Red Route as specified in Schedule 10; and
 - stop at any time in the length of the Red Route as specified in Schedule 11 at any time.

6. PROHIBITION OF STOPPING EXEMPTIONS

- 1) The controls as specified in Articles 5, 6, 7, and 8 do not apply in respect of a person causing or permitting a vehicle to stop if that person is:
 - a. required by law to cause the vehicle to stop or not to proceed:
 - b. obliged to stop the vehicle so as to avoid an accident;
 - c. prevented from proceeding in the vehicle by circumstances beyond the person's control;
 - d. getting or giving help in consequence of an accident or an emergency, or otherwise taking action for public safety;
 - e. opening or closing a gate or other barrier at the entrance to premises to which the vehicle is being driven or from which it has emerged if it is not reasonably practicable to cause the vehicle to stop elsewhere for the purpose;
 - f. using the vehicle for fire brigade, ambulance or police purposes;
 - g. using the vehicle in connection with the removal of any obstruction to traffic:
 - h. using the vehicle in connection with the maintenance, improvement or reconstruction of any part of the Red Route or the Red Route area;
 - i. using the vehicle in connection with the laying, erection, alteration or repair in or on land adjacent to the Red Route of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984 (as amended):

j. using a vehicle in the service of a local authority, water authority or sewerage authority or their agents and in either case the vehicle is being used in pursuance of statutory powers or duties.

PART III WAITING AND LOADING OF VEHICLES

- No person shall, except upon the direction or with the permission of a Police Constable in uniform or a civil enforcement officer, cause or permit any vehicle during each separately dated day, to:-
 - wait at any time in the length of road specified in Schedule 4;
 - wait Monday to Saturday inclusive from 8am-6.30pm in the length of road specified in Schedule 9;
 - wait and /or load at any time in the length of road specified in Schedule 13;
 - wait Monday to Saturday 8am-6.30pm 30mins, with no return within 30mins as specified in Schedule 15; and
 - wait Monday to Saturday 8am-10am and 4pm-6.30pm 30 minutes with no return within 30 minutes, except 10am-4pm Monday - Saturday for Goods vehicles loading for a maximum 20 minutes only as specified in Schedule 16.

8. WAITING AND LOADING OF VEHICLES EXEMPTIONS

- (1) Nothing in Article 6 shall apply to any vehicle waiting in the lengths of roads referred to therein for so long as it may be necessary to enable:-
 - (a) a person to board or alight from the vehicle;
 - (b) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the maintenance, improvement or reconstruction of the said lengths of roads:
 - (iv) the laying, erection, alteration or repair in or in land adjacent to the said lengths of roads of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications system;
 - (v) the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
 - (c) the vehicle to be used for the purpose of providing a postal service as defined in section 27 Postal Services Act 2011;
 - (d) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said lengths of roads;
 - (f) the vehicle being used for fire brigade, ambulance or police purposes.

- (2) Nothing in Article 6 shall apply to any vehicle:
 - a) waiting upon an authorised parking place; or
 - (b) waiting for so long as may be necessary to enable the vehicle to be used in the provision of a local service within the meaning of the Transport Act 1985.

PART IV DISABLED PERSON'S BADGE HOLDERS

- 9. No person shall, except upon the direction or with the permission of a Police Constable in uniform or a civil enforcement officer, cause or permit any vehicle other than a disabled person's vehicle, displaying a Disabled Person's Badge:
 - (a) to wait in the length of roads specified in Schedule 7 Mondays to Sundays;
 - (b) to wait in the length of road specified in Schedule 14 Mondays to Sundays inclusive for a period of 1 hour with no return within 1 hour since the previous period of waiting by the same vehicle in the same length of road on the same day has elapsed; AND

provided that the Disabled Person's Vehicle also displays in the relevant position, a Parking Disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began).

PART V AUTHORISATION AND USE OF PARKING PLACES

- 10. The lengths of roads specified in Schedule 12 are authorised to be used:
 - (a) as parking places for the parking during the permitted hours as are specified in the said Schedule, of a vehicle displaying in the relevant position a valid Residents Parking Permit issued by the Council AND
 - (b) for vehicles to wait between 08.00am and 08.00pm on Mondays to Sundays inclusive for a period of 2 hours excepting if a period of less than 2 hours has elapsed since the previous period of waiting by the same vehicle in the same length of road;
 - (c) at all other times permit holders only.
- 11. Where in the Schedules a parking place is described as available for vehicles of a specific class or in a specified position, the driver of a vehicle shall not permit it to wait in the parking place unless it:-
 - (a) is of the specified class; or as the case may be -
 - (b) is in the specified position;
 - (c) displays a valid parking permit issued by the Council.
- **12.** A driver of a vehicle shall not use a parking place so as to unreasonably prevent access to any premises adjoining the road, or the use of the road by any other person, or so as to be a nuisance.

- **13.** A driver of a vehicle shall not use a parking place when a Police Constable in uniform, a civil enforcement officer or a or a person authorised by the Council has closed the parking place.
- 14. The driver of a motor vehicle using a parking place shall stop the engine as soon as the vehicle is in position in the parking place and shall not start the engine except when about to change the position of the vehicle in, or to depart from, that parking place.
- 15. No person shall use a vehicle whilst it is in a parking place in connection with the sale of any article to persons in or near the parking place, or in connection with the selling or offering for hire of his skill or services.
- 16. When a vehicle is left in a parking place in contravention of the provisions of Article 10, a Police Constable in uniform, or a parking attendant or a person authorised by the Council to do so may alter or cause to be altered the position of the vehicle so that its position shall comply with that provision.
- **17.** Any person altering the position of a vehicle by virtue of Article 11 may do so in such manner as he thinks necessary.
- **18.** A Police Constable in uniform, or a civil enforcement officer or a person authorised by the Council to do so may, in case of emergency, or in contravention of Article 10, remove or cause to be removed to any place he thinks fit any vehicle left in a parking place.
- **19.** Any person removing or causing to be removed a vehicle from a parking place in accordance with Article 10 shall provide for the safe custody of the vehicle.

PART VI PERMITS

- 20. (1) Any resident, who is the owner of a vehicle of the following class, that is to say a passenger vehicle, a goods vehicle, or an invalid carriage may apply to the Council or an authorised agent for a permit for the parking of that vehicle in a parking place specified in paragraph (5) of this Article and any such application shall be made on a form issued by and obtainable from the Council or authorised agent and shall include the particulars and information required by such form to be supplied.
 - (2) The Council or authorised agent may at any time require an applicant for a permit or a permit holder to produce to an officer of the Council or authorised agent such evidence in respect of an application for a permit as they may reasonably require to verify the particulars or information given to them or to verify that the permit is valid.
 - (3) The Council or authorised agent upon being satisfied that the applicant is:-
 - (a) a resident who is the owner of a vehicle of the class specified in paragraph (1) of this Article, shall issue to the applicant a Residents Parking Permit for the leaving during the permitted hours in a parking place of the vehicle to which such permit relates, by the owner or by any person using such vehicle with the consent of the owner (other than a person to whom such vehicle has been let for hire and reward);
 - (b) a Doctor, who is the owner of a vehicle of the class specified in paragraph
 (1) of this Article, shall issue to the applicant one (1) Doctors Parking
 Permit for the leaving at any time in the Doctors Parking Place specified

thereon such vehicles as they are satisfied are used by fully registered persons who are liable to be called of necessity to emergencies away from the surgery or consulting room shown on the application to the extent that the need for special parking arrangements is justified and to whom no suitable alternative parking facility is available within a reasonable distance.

- (4) A resident shall not be entitled to be in possession of more than one permit at any one occasion.
- 21. Notwithstanding the provisions contained in Article 20 the Council may also grant permits to such other persons as they may think fit.
- 22. (1) A permit holder (whether of a Residents or Doctors Parking Permit), may surrender such permit to the Council or authorised agent at any time and shall surrender such permit to the Council or authorised agent on the occurrence of any one of the events set out in paragraph (3) of this Article.
 - (2) The Council or authorised agent may, by notice in writing served on the permit holder at the address shown by that person on the application for the permit or at any other address believed to be that person's residence, withdraw a permit if it appears to the Council or authorised agent that any one of the events set out in paragraph (3) of this Article has occurred and the permit holder shall surrender the permit to the Council or authorised agent within 48 hours of the receipt of the aforementioned notice.
 - (3) The events referred to in the foregoing provisions of this Article are:-
 - (a) the permit holder ceasing to be a resident;
 - (b) the permit holder ceasing to be the owner of the vehicle in respect of which the permit was issued;
 - (c) the vehicle in respect of which such permit was issued being adapted or used in such a manner that it is not a vehicle of the class specified in Article 18(1);
 - (d) the issue of a duplicate permit by the Council under the provisions of Article 19:
 - (e) the expiry of the period for which the permit was issued;
 - (f) where a permit is issued to any person upon receipt of a cheque and the cheque is subsequently dishonoured, the permit shall cease to be of any effect;
 - (g) in the case of a fully registered person holding a Doctor's Parking Permit:-
 - (i) the vehicle or any vehicle in respect of which the permit was issued ceasing to be used by a fully registered person who is liable to be called of necessity to emergencies away from the surgery or consulting room shown on the application for the permit to the extent that the need for special parking arrangements is justified;
 - (ii) the revocation of the designation of the parking place in respect of which the permit was issued.

- **23.** Without prejudice to the provisions of Article 20, a permit shall cease to be valid at the expiration of the period specified thereon:-
 - (a) which period, in the case of a Residents or Doctors Permit, shall not exceed a period of twenty-three months from the end of the month during which it first became valid;

or on the occurrence of any one of the events set out in paragraph (3) of Article 22, whichever is the earlier.

- 24. (1) A holder of a Doctors Parking Permit, may at any time apply to the Council or authorised agent for a permit issued to him to be amended so as to relate to any other vehicle, being a vehicle which is used by a fully registered person who are liable to be called of necessity to emergencies away from the surgery or consulting room shown on the application to the extent that the need for special parking arrangements can be justified.
 - (2) Upon receipt of an application pursuant to paragraph (1) of this Article and of the relevant permit, the Council or authorised agent may amend the permit accordingly, or to such extent as they think fit, or at their discretion issue a revised permit, and if a revised permit is so issued, the permit shall become invalid and shall be surrendered to the Council.
- 25. (1) If a permit is accidentally mutilated or defaced or the figures or particulars thereon have become illegible or the colour of the permit has become altered by fading or otherwise, the permit holder shall surrender it to the Council or authorised agent and apply to the Council or authorised agent for the issue to him of a duplicate permit, whereupon Council or authorised agent, shall issue a duplicate permit so marked and upon such issue the original permit shall become invalid.
 - (2) If a permit is lost or destroyed, the permit holder may apply to the Council or authorised agent for the issue to him of a duplicate permit and the Council or authorised agent upon being satisfied as to such loss or destruction, shall issue a duplicate permit so marked and upon such issue the permit shall become invalid.
 - (3) All the provisions of this Order shall apply to a duplicate permit to the same extent as they applied to the original permit.
- 26. A permit shall be in writing and shall include the following particulars:-
 - (a) the registration mark of the vehicle in respect of which the permit has been issued;
 - (b) the period during which, subject to the provisions of Article 20, the permit shall remain valid;
 - (c) an authentication that the permit has been issued by the Council;
 - (d) a code indicating the parking area for which the permit is valid.
- 27. At all times during which a vehicle is left in a parking place specified in Schedules 13, or 16 during the permitted hours, there shall be displayed in the relevant position a permit issued in respect of that vehicle valid for parking place.
- 28. When a permit has been displayed in accordance with the provisions of Article 25, or where a penalty charge notice has been attached to the vehicle, no person other than a Police Constable in uniform, or a parking attendant shall remove such permit or notice from the vehicle unless authorised to do so by the driver of that vehicle.

29. Notwithstanding the foregoing provisions of this Order, the Council may at its discretion issue a discretionary notice allowing a specific vehicle to wait in a road or a parking place during the hours of operation of any restriction or prohibition to the contrary.

PART V GENERAL ORDER EXEMPTIONS

- **30.** The controls specified in Articles 5, 6 and 7 do not apply in respect of a person causing or permitting a Hackney Carriage, a Licensed Taxi to stop on a designated Taxi Rank during the hours of operation.
- 31. The controls specified in Articles 5, 6, and 7 do not apply in respect of a person causing or permitting a Hackney Carriage or a Licensed Taxi to stop except for so long only as may be required to enable waiting passenger(s) to board or alight the vehicle.
- 32. The controls specified in Articles 5, 6, 7 and 8 do not apply in respect of a person causing or permitting a vehicle displaying a Disabled Person's Badge in the Relevant Position to stop for so long only as may be required to enable a disabled person to get in to or out of the vehicle.
- 33. The controls specified in Articles 5, 6, 7 and 8 do not apply in respect of a person causing or permitting a vehicle which bears the livery of Royal Mail to stop for as long as may be necessary to actively load and/or unload as necessary for the purposes of the provision of a postal service (as defined in s27 Postal Services Act 2011).
- 34. The controls specified in Articles 5, 6, 7 and 8 do not apply in respect of any persons causing or permitting a funeral Hearse to stop at or near any premises situated on or adjacent to the Red Route so long as it reasonably necessary to do so in connection with any funeral.
- **35.** The controls specified in Articles 5, 6, 7 and 8 do not apply to anything done with the permission of an Authorised Person or with the permission or at the direction of a police constable in uniform or a Civil Enforcement Officer.
