

REDCAR AND CLEVELAND BOROUGH COUNCIL
(RESIDENT PARKING) (CONSOLIDATION) ORDER 2003

Redcar and Cleveland Borough Council (hereinafter called "the Council") under Sections 32(1) and 35(1) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the Act of 1984) and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order:-

Part I - GENERAL

1. This Order shall come into operation on the 14th day of May 2003 and may be cited as "THE REDCAR AND CLEVELAND BOROUGH COUNCIL (RESIDENT PARKING) (CONSOLIDATION) ORDER 2003".
2.
 - (1)
 - (a) The Interpretation Act 1978 shall apply to this Order as it does to an Act of Parliament
 - (b) Where a provision of this Order is in conflict with a provision contained in a previous order, the provision of this Order shall prevail
 - (c) Where a statute, statutory instrument, specification or regulations are referred to such reference shall include an amendment to or replacement thereof.
 - (2) In this Order all expressions except as otherwise herein provided shall have the meanings assigned to them by the Act of 1984:-

"Business" means a person not being a resident who satisfies the Council that he operates, manages or is employed at any commercial premises the address of which is in any road or part of the road specified within the Zone in the Schedule to this Order and who is the owner of a vehicle which the Council is satisfied should receive a permit. Business permits will be limited to one per business premise within the Zone.

"Delivering and collecting" in relation to any goods includes checking the goods for the purpose of their delivery or collection.

"Dual purpose vehicle" has the same meaning as in Schedule 6 to the Act.

"Disabled Persons Badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 1982 as amended.

"Disabled Persons Vehicle" A vehicle lawfully displaying a disabled persons badge.

“Goods vehicle” means a motor vehicle not exceeding 30 cwt unladen weight which is constructed or adapted for use for the carriage of goods or burden of any description and is not drawing a trailer.

“Owner” in relation to the vehicle means the person by whom such vehicle is kept or regularly used.

“Parking place” means any part of a road authorised by this Order to be used as a parking place.

“Passenger vehicle” means a motor vehicle (other than a motor cycle or a disabled person’s vehicle) constructed solely for the carriage of passengers and their effects and adapted to carry not more than 12 passengers exclusive of the driver, and not drawing a trailer.

“Permit” means a permit issued under the provisions of Article 11 of this Order.

“Permit holder” means a person to whom a permit has been issued under the provisions of Article 11 of this Order.

“Relevant position” in relation to a permit means (a) in the case of a vehicle fitted with a front windscreen, on the near side of and immediately behind the windscreen with the obverse side thereof facing forwards or (b) in the case of a vehicle not fitted with a front windscreen, in a conspicuous position on the front or near side of the vehicle.

“Resident” in relation to any parking place specified within a Zone in Part 2 of any Schedule to this Order means a person whose usual residence is at the premises the postal address of which is in a Zone specified in Part 1 of that Schedule to this Order.

“Telegraphic line” has the same meaning as in the Telegraph Act 1878.

“Valid Permit” means a permit issued by the Council in accordance with the provisions of this Order being specific to Zone. The permit shall display an identification letter or series of alphanumeric characters that correlates with the traffic signs at the Parking Place and the Parking Places designated for that Zone in Part 2 of the relevant sub schedule to Schedule 6.00.

“Visitor” means a person not being a resident who satisfies the Council that he has valid and sufficient reason for regularly visiting a resident within a Zone during such hours and for such period as to make it unreasonable for that person to park other than in a parking place

“Zone” means an area comprising of a number of premises specified in an individual sub-schedule of Part 1 to Schedule 6.00, each Zone being listed within its own sub-schedule and being identified by unique letter or series of alphanumeric characters. For the purposes of this Order each Zone operates

independently, permits only being valid within the Parking places associated with the said Zone.

- (3) In the event of any contravention of or non-compliance with a provision of this Order then for the purposes of this Order and any legal proceedings taken thereunder (a) the permit holder, or in the event of the vehicle not being one for which a permit has been issued (b) the registered keeper of the vehicle on the date the offence took place shall be deemed to be the person responsible for the offence unless the contrary is shown.

Part II - PARKING SCHEME

Contravention

3. (1) Each of the roads or parts of road specified in Part 2 of each sub-schedule of Schedule 6.00 to this Order is authorised as a parking place for use, subject to the following provisions of this Order, for the parking during such hours or such days and in such positions as are specified in this Order of such classes of vehicles, also so specified.
 - (2) The driver of a vehicle shall not permit it to wait continuously in a parking place for longer than the maximum period specified in Schedule 6.0 to this Order.
 - (3) When a vehicle has left a designated limited waiting parking place after waiting therein the driver thereof shall not within two hours after leaving it permit it to wait again in that parking place or any other parking place within the restricted road.
 - (4) Nothing in paragraphs (2) and (3) of this Article shall apply to a vehicle which displays in the relevant position a valid permit issued by the Council in respect of that vehicle

Exemptions

4. (1) Notwithstanding Article 3 of this Order, any vehicle may wait in a parking place (other than a parking place or part of a parking place the use of which has been suspended, under Article 5 of this Order) for so long as may be necessary if:-
 - (a) the vehicle is waiting to enable a person to board or alight from the vehicle.
 - (b) the vehicle is waiting owing to the driver being prevented from proceeding by circumstances beyond his control or to such waiting being necessary in order to avoid accident.
 - (c) the vehicle is a vehicle used for police, fire brigade or ambulance purposes, or a vehicle (other than a passenger vehicle) in the service of a local authority which is being used in pursuance of statutory powers or duties.

- (d) the vehicle is a vehicle used by a doctor or a nurse who is on call and which displays an "on call" sign.
 - (e) the vehicle is waiting to enable it to be used in connection with the removal of an obstruction to traffic.
 - (f) the vehicle is in the service of or employed by the Post Office or the British Telecommunications Corporation and is waiting while postal packets addressed to premises adjacent to the parking place in which the vehicle is waiting are being unloaded from the vehicle or, having been unloaded therefrom, are being delivered or while postal packets are being collected from premises or posting boxes adjacent to the parking place in which the vehicle is waiting, or is in use in connection with the servicing of telephone kiosks adjacent to the parking place.
 - (g) the vehicle (not being a passenger vehicle) is waiting to enable to be used for the purpose of any building operation demolition or excavation in or adjacent to the parking place, the maintenance, improvement or reconstruction of the parking place or the laying, erection, alteration, removal or repair in or adjacent to the parking place of any sewer or of any mains pipes or apparatus for the supply of gas, water or electricity or of any telegraphic line or traffic sign.
 - (h) the vehicle is in actual use in connection with the removal of furniture from one office or dwellinghouse to another or the removal of furniture from such premises to a depository or to such premises from a depository.
 - (i) the vehicle is waiting to enable it to be used in connection with posting or removing advertising material in the form of posters on or from, or cleaning windows or chimneys in, premises adjacent to the parking place.
 - (j) in any other case the vehicle is waiting for the purpose of delivering or collecting goods or of loading or unloading the vehicle at or from premises adjacent to the parking place and the vehicle does not wait for such purpose for more than 20 minutes.
- (2) Nothing in the foregoing provisions of this Article shall be taken as authorising anything which would be a contravention of any regulations made or having effect as if made under Section 25 of the Act.

Suspensions

5. (1) Any person authorised by the Council may suspend the use of a parking place or any part thereof whenever he considers such suspension reasonably necessary:-

- (a) for the purpose of facilitating the movement of traffic or promoting its safety
 - (b) on any occasion on which it is likely by reason of some special attraction that any road containing a parking place may be thronged or obstructed, or
 - (c) for the convenience of occupiers of premises adjacent to the parking place at times of weddings or funerals or on other special occasions.
- (2) A police constable in uniform may suspend for not longer than 24 hours the use of a parking place or any part thereof when he considers such suspension reasonably necessary for the purpose of facilitating the movement of traffic or promoting its safety.
- (3) Any person suspending the use of a parking place or any part thereof in accordance with the provisions of paragraph (1) or (2) of this Article shall thereupon or as soon as reasonably practicable thereafter place or cause to be placed in or adjacent to that parking place or the part thereof the use of which is suspended a traffic sign indicating that waiting by vehicles is prohibited.
- (4) No person shall cause or permit a vehicle to be left in any parking place or part of a parking place during such period as there is in or adjacent to that parking place or part of a parking place a traffic sign placed in pursuance of paragraph (3) of this Article provided that nothing in this paragraph shall render it unlawful to cause or permit any vehicle being used for any purpose specified in article 4(1)(b), (c), (e) or (f) of this Order to be left in the parking place or part of a parking place during any such period, or to any other vehicle so left if that vehicle was left with the permission (a) of the person suspending the use of the parking place or part thereof in pursuance of paragraph (1) of this article (b) a police constable in uniform, or (c) traffic warden.

Other Conditions

- 6. A driver of a vehicle shall not use the parking place
 - (a) so as unreasonably to prevent access to any premises adjoining the road or the use of the road by other persons or
 - (b) so as to be a nuisance.
- 7. No person shall use the vehicle, while it is in a parking place during the permitted hours, in connection with the sale of any article to persons in or near that road or in connection with the selling or offering for hire of his skill or services.
- 8. (1) When a vehicle is left in a parking place in contravention of any provisions contained in this Order a person authorised by the Council may remove the vehicle or arrange for it to be removed from that parking place provided that when a vehicle is waiting in a parking place in contravention of the provisions of Article 10 of this Order a person authorised by the Council, may alter or

cause to be altered the position of the vehicle so that its position shall comply with that provision.

- (2) Any person so removing the vehicle or altering its position may do so in such a manner as he thinks necessary.
 - (3) Any person so removing the vehicle shall make such arrangements as may be necessary for the safe custody of the vehicle.
9. A police constable in uniform or a traffic warden may in any case of emergency move or cause to be moved any vehicle left in a parking place to any place he thinks fit.
10. Every vehicle left in a parking place in accordance with the foregoing provisions of this Order shall so stand so that every part of the vehicle is within the limits of the parking place.

Part III - PERMITS

11. (1) Any resident, visitor or business who is the owner of a passenger vehicle, or a dual purpose vehicle, a goods vehicle, a disabled persons vehicle or a motor cycle may apply to the Council for the issue of a permit to leave that vehicle in a parking place in the zone in which he or she is a resident or visitor and any such application shall be made on a form issued by and obtainable from the Council and shall include the information required by such form.
- (2) The Council may require an applicant for a permit to produce to an Officer of the Council such evidence in respect of the application as they may reasonably require to verify any particulars or information given to them.
- (3) The Council, upon being satisfied that an applicant is a resident, visitor or business and is the owner of a vehicle of a class specified in paragraph (1) of this Article and satisfies the criteria specified in schedule 1 of the relevant sub-schedule may issue to that applicant:
 - (a) one permit to park the vehicle in the parking place to which the permit relates which may be exercised by the owner of such vehicle or by any person using such vehicle with the consent of the owner other than a person to whom such vehicle has been lent for hire or reward.
 - (b) one protective cover for the display or a permit.
12. (1) A permit holder may surrender a permit to the Council at any time and shall surrender a permit to the Council on the occurrence of any of the events set out in paragraph (3) of this Article.
- (2) If the Council has reason to believe that the permit holder has not surrendered a permit which has ceased to be valid or has obtained a permit by false representations then the Council may, by notice in writing served on the permit holder at the address shown by that person on the application for the permit or at any other address believed to be that persons residence, inform the permit holder that the permit is not valid and may no longer be used.
- (3) A permit shall cease to be valid on the occurrence of any of the events set out in this Article:-
 - (a) the permit holder ceasing to be a resident.
 - (b) the permit holder ceasing to be the owner of the vehicle in respect of which the permit was issued.
 - (c) the vehicle in respect of which such permit was issued being adapted or used in such a manner that it is not a vehicle of the class specified when the said permit was issued.
 - (d) the permit being altered defaced or misused.

- (e) the issue of a duplicate permit by the Council under the provision of Article 13 of this Order.
- 13.
 - (1) If a permit has become so mutilated or faded as to cease to be effectively legible when displayed on a vehicle the permit holder shall surrender it to the Council and may then apply to the Council for the issue of a duplicate permit.
 - (2) If a permit is lost or destroyed, the permit holder may apply to the Council for the issue of a duplicate permit.
 - (3) The provisions of this Order shall apply to a duplicate permit and an application for such a permit as if it were a permit or, as the case may be, an application for permit.
- 14.
 - (1) A permit shall be in writing and shall include the following particulars:-
 - (a) An indication as to whether the permit applies to a resident, visitor or a business.
 - (b) The registration mark of the vehicle in respect of which the permit has been issued. (unless excluded for reasons which the Council deem to be reasonable)
 - (c) The permit number.
 - (d) The period for which the permit has been issued.
 - (e) An authentication that the permit has been issued by the Council.
 - (f) A letter or series of alphanumeric characters identifying the zone for which the permit is issued.

Part IV – Other Articles

- 15 The restrictions imposed by this Order shall be in addition to and not in derogation from any restrictions or requirements imposed by any Regulation made or having effect as if made under the Act of 1984 or by any other enactments.
16. The Orders specified in Part V to this Order are hereby revoked in full or to the extent indicated, and in the case of the latter in all other respects the said Orders shall continue to have effect.
