(AMENDMENT TO WAITING RESTRICTIONS) VARIATION ORDER 2019

The Rhondda Cynon Taff County Borough Council ("the council") in exercise of their powers under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 (as amended), and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following order:

- 1. The Traffic Regulation Order specified in the Schedule to this Order is hereby varied.

This Order shall come into operation on 19th April 2019 and may be cited as the "Rhondda Cynon Taff County Borough Council (Cambrian Park Industrial Estate Access Road, Clydach vale, Tonypany) (Amendments to Waiting Restrictions) Variation Order 2019"

SCHEDULE - Variations

The "Rhondda Cynon Taff County Borough Council (Cambrian Park Industrial Estate Access Road and Cambrian Industrial Park Road, Clydach Vale, Tonypany) (Waiting Restrictions) Order 2013" shall be varied so that item 1(i) of the Schedule Prohibition of Waiting At Any Time - Cambrian Industrial Estate Access Road North Side shall now read:

"From a point 10 metres south east of the eastern kerbline of the unnamed road leading to the visitor centre westwards for a distance of 80 metres

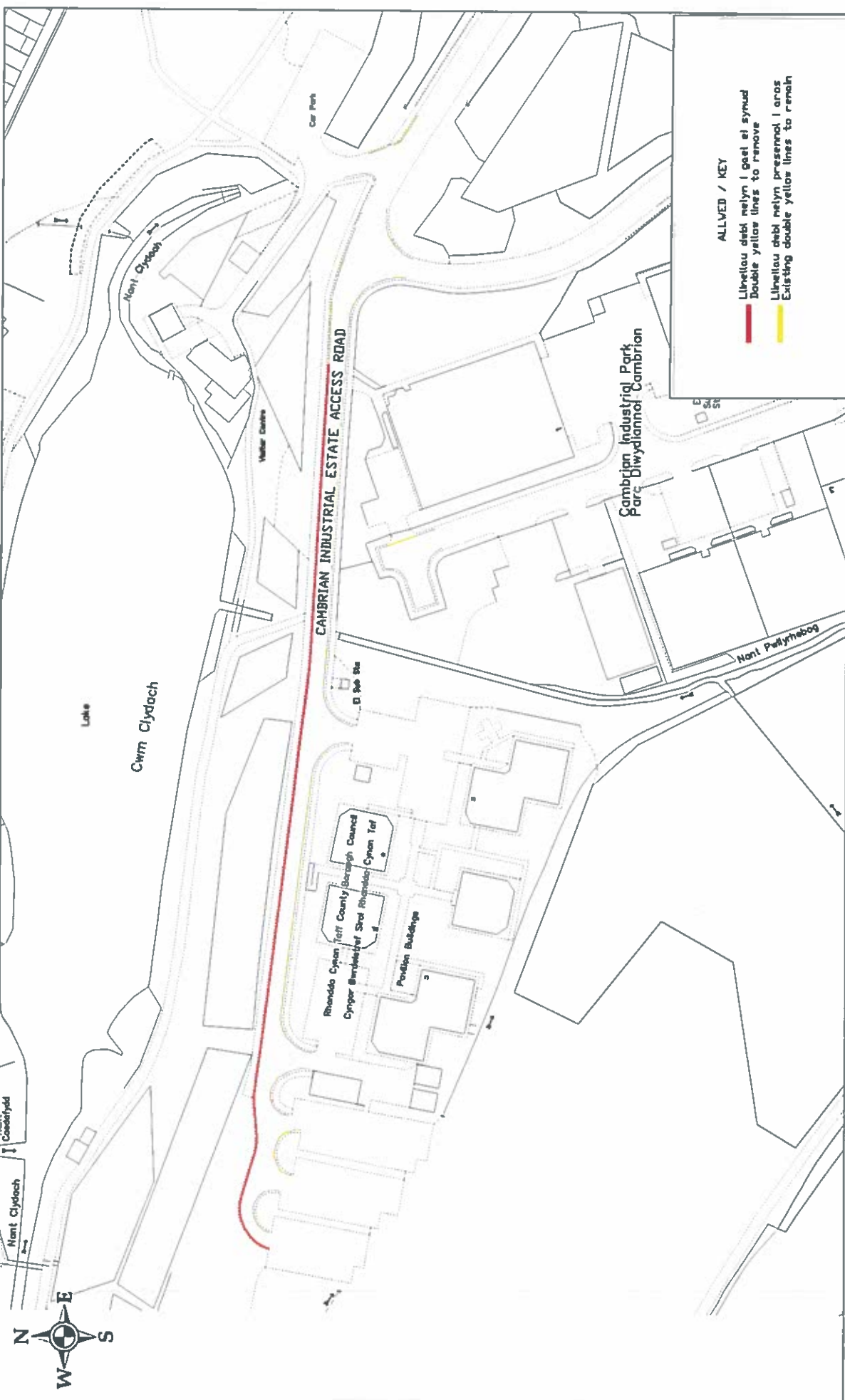
