(AMENDMENT) (NO. 12) ORDER 2008

Bury New Road, Heywood

The Rochdale Borough Council, in exercise of its powers under Sections 1(1), 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Section 124(1) and paragraph 20(1) of Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as the Borough of Rochdale ((Civil Enforcement of Traffic Contraventions) (Various Streets) (Heywood Township) Order 2008) (Amendment) (No. 12) Order and shall come into operation on 1st December 2008.
2. The Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Heywood Township) Order 2008 is hereby amended by inserting the wording shown in Schedule One to this Order.
3. That part of the Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Heywood Township) Order 2008, as shown in Schedule Two to this Order be hereby revoked.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

SCHEDULE ONE

Schedule No. 1.1
No Waiting At Any Time

Bury New Road, West Heywood Ward

n (i) the north side from the east side boundary of No. 46 Bury New Road in a westerly direction to its junction with Roch View.

n (ii) the north side from its junction with Roch View for a distance of approximately 80 metres in a westerly direction up to the Borough Boundary

Roch View, West Heywood Ward

n (i) the east side from its junction with Bury New Road for a distance of 10 metres in a northerly direction.

n (ii) the west side from its junction with Bury New Road for a distance of 10 metres in a northerly direction.

Bury New Road, West Heywood Ward


(i) the north side from the east boundary of No. 46 Bury New Road for a distance of 36 metres in a westerly direction.

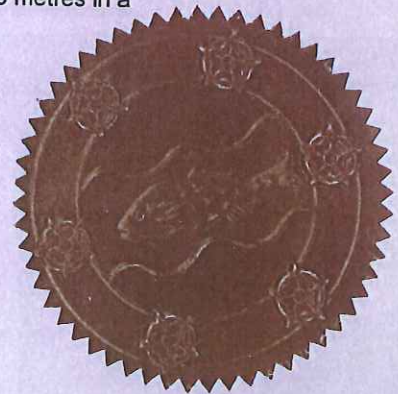
