MORRISONS, KINGSWAY, ROCHDALE

The Rochdale Borough Council, in exercise of its powers under Sections 1(1), 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Section 124(1) and paragraph 20(1) of Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the Borough of Rochdale ((Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008) (Amendment) (No. 22) Order 2010 and shall come into operation on 1st May 2010.
- 2. The Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008 is hereby amended by inserting the wording shown in the Schedule to this Order.
- 3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.


- n (i) the north west side from its junction with Morrison's Access Road for a distance of 130 metres in a south westerly direction.
- n (ii) the north west side from its junction with Morrison's Access Road for a distance of 66 metres in a north easterly direction.
- n (iii) the north west side from its junction with Nigher Moss Avenue for a distance of 15 metres in a south westerly direction.
- n (iv) the north west side from its junction with Nigher Moss Avenue for a distance of 15 metres in a north easterly direction.
- n (v) the south east side from its junction with Moss Avenue for a distance of 152 metres in a south westerly direction.
- n (vi) the south east side from its junction with Moss Avenue for a distance of 13 metres in a north easterly direction.
