TWEEDALE STREET, ROCHDALE

The Rochdale Borough Council, in exercise of its powers under Sections 1(1), 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Section 124(1) and paragraph 20(1) of Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the Borough of Rochdale ((Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008) (Amendment) (No. 31) Order 2010 and shall come into operation on 1st December 2010.
- 2. The Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008 is hereby amended by inserting the wording shown in Schedule No.1 to this Order.
- Those parts of the Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008, as shown in Schedule 2 to this Order be hereby revoked.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

SCHEDULE 1

Schedule No. 1.1 No Waiting at Any Time

Tweedale Street, Milkstone and Deeplish Ward

n (i) the north westerly side, from a point 40 metres north east of its junction with Manchester Road, to a point 9 metres north east of its junction with Mere Street.

Castlemere Street, Milkstone and Deeplish Ward

n (i) both sides from its junction with Tweedale Street for a distance of 15 metres in a northerly direction.

SCHEDULE 2

Schedule No. 1.1 No Waiting at Any Time

Tweedale Street, Milkstone and Deeplish Ward

- (ii) the north side from its junction with Mere Street to a point 9 metres east of its junction with Mere Street.
- (iii) the north side from its junction with Mere Street to a point 48 metres east of its junction with Castlemere Street.

Schedule No. 2.2 No Waiting Mon – Sat, 8am – 6pm

Tweedale Street, Milkstone and Deeplish Ward

- (i) the north side from its junction with Castlemere Street to a point 48 metres east of its junction with Castlemere Street.
- (ii) the north side from a point 40 metres west of its junction with Manchester Road to its junction with Boundary Street.



The Rochdale Borough Council, in exercise of its powers under Sections 84(1) and 84(2) of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Section 124(1) and paragraph 20(1) of Part III of Schedule 9 to the Act hereby makes the following Order:-

- This Order may be cited as The Borough of Rochdale (Tweedale Street, Rochdale) (20 mph Speed Limit) Order 2010 and shall come into force on 1st December 2010
- 2. No person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the length of road specified in the Schedule to this Order.
- 3. Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 5. The Prohibition imposed by this Order is in addition to and not in derogation of any restriction, prohibition or requirement imposed by any other enactment and any exception or exemption from the provision of this Order is without prejudice to the provisions of any other enactment.

SCHEDULE

Restriction to 20 m.p.h.

Tweedale Street, Rochdale from a point 7 metres east of its junction with Milkstone Road to a point 40 metres north east of its junction with Manchester Road.
