# BOROUGH OF ROCHDALE ((CIVIL ENFORCEMENT OF TRAFFIC CONTRAVENTIONS) (VARIOUS STREETS) (MIDDLETON TOWNSHIP) ORDER 2008) (AMENDMENT) (NO. 18) ORDER 2010

## ST ANNE'S ACADEMY, STOTT LANE, MIDDLETON

The Rochdale Borough Council, in exercise of its powers under Sections 1(1), 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Section 124(1) and paragraph 20(1) of Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the Borough of Rochdale ((Civil Enforcement of Traffic Contraventions) (Various Streets) (Middleton Township) Order 2008) (Amendment) (No. 18) Order 2010 and shall come into operation on 15<sup>th</sup> November 2010.
- The Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Middleton Township) Order 2008 is hereby amended by inserting the wording shown in Schedule 1 to this Order.
- 3. That part of the Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Middleton Township) Order 2008, as shown in Schedule 2 to this Order be hereby revoked.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

## SCHEDULE1

# Schedule No. 1.1 No Waiting at Any Time

#### Hazelhurst Drive, Hopwood Hall Ward

n (i) both sides from its junction with Hollin Lane in an easterly direction to a point 10 metres east of Winwood Fold.

## Hollin Lane, West Middleton Ward

n (ii) the westerly side from a point 70 metres south of its junction with Hillcrest to a point 145 metres north of its junction with Hollins Drive.

#### Hollin Lane, Hopwood Ward


n (i) the easterly side from its junction with Hazelhurst Drive for a distance of 42 metres in a northerly direction.

# Rosethorns Close, Hopwood Hall Ward

n (i) both sides from its junction with Hazelhurst Drive for a distance of 10 metres in a south-westerly direction.

#### Stott Lane, Hopwood Hall Ward

n (i) both sides from its junction with Hazelhurst Drive for a distance of 150 metres in a northerly direction including the perimeters of all the islands but excluding the marked parking bays.

n (i) the westerly side from a point 70 metres south of its junction with Hillcrest to a point 130 metres north of its junction with Hollins Drive.
