



BOROUGH OF ROCHDALE ((CIVIL ENFORCEMENT OF TRAFFIC CONTRAVENTIONS) (VARIOUS STREETS) (ROCHDALE TOWNSHIP) ORDER 2008) (AMENDMENT) (NO. 48) ORDER 2011

The Rochdale Borough Council, in exercise of its powers under Sections 1(1), 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Section 124(1) and paragraph 20(1) of Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the Borough of Rochdale ((Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008) (Amendment) (No. 48) Order 2011 and shall come into operation on 1st July 2011.
- 2. The Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008 is hereby amended by inserting the wording shown in Schedule One to this Order.
- 3. That parts of the Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008, as shown in Schedule Two to this Order be hereby revoked.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

- n (iii) the easterly side from a point 15 metres south of its junction with Bolton Road to a point 15 metres north of its junction with Honister Way

- n(i) the westerly side from a point 64 metres south of its junction with Bolton Road to a point 107.56 metres south of its junction with Bolton Road
- n (ii) the westerly side from a point 126.06 metres south of its junction with Bolton Road to a point 169.62 metres south of its junction with Bolton Road
