(AMENDMENT) (NO. 25) ORDER 2011

Pennine Drive/Cornfield Street/Moorland Avenue. Milnrow

The Rochdale Borough Council, in exercise of its powers under Sections 1(1), 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Section 124(1) and paragraph 20(1) of Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as the Borough of Rochdale ((Civil Enforcement of Traffic Contraventions) (Various Streets) (Pennines Township) Order 2008) (Amendment) (No. 25) Order 2011 and shall come into operation on 1st November 2011.
2. The Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Pennines Township) Order 2008 is hereby amended by inserting the wording shown in Schedule 1 to this Order.
3. Those parts of the Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Pennines Township) Order 2008, as shown in Schedule 2 to this Order be hereby revoked.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

n(i) both sides from a point 25 metres west of its junction with Pennine Drive to its termination in an easterly direction at the southerly entrance to the school (a distance of approximately 45 metres)

Moorland Avenue, Milnrow & Newhey Ward

n(i) both sides from its junction with Pennine Drive to a point 15 metres west of its junction with Pennine Drive

Pennine Drive, Milnrow & Newhey Ward

n(i) easterly side from its junction with Cornfield Street to a point 12 metres north of its junction with Cornfield Street

n(ii) easterly side from a point 38 metres north of its junction with Cornfield Street to a point 30 metres north of the northerly kerb line of Moorland Avenue

n(iii) westerly side from its junction with Moorland Avenue to a point 30 metres north of its junction with Moorland Avenue

- n(i) easterly side from a point 12 metres north of its junction with Cornfield Street to a point 38 metres north of its junction with Cornfield Street

Cornfield Street, Milnrow & Newhey Ward

- n(i) both sides from a point 25 metres west of its junction with Pennine Drive to its termination in an easterly direction at the southerly entrance to the school (a distance of approximately 45 metres)

Moorland Avenue, Milnrow & Newhey Ward

- n(i) both sides from its junction with Pennine Drive to a point 15 metres west of its junction with Pennine Drive

Pennine Drive, Milnrow & Newhey Ward

- n(i) easterly side from its junction with Cornfield Street to a point 12 metres north of its junction with Cornfield Street
n(ii) easterly side from a point 38 metres north of its junction with Cornfield Street to a point 30 metres north of the northerly kerb line of Moorland Avenue
n(iii) westerly side from its junction with Cornfield Street to a point 30 metres north of its junction with Moorland Avenue

- (i) the east side from a point 6 metres north of the northerly kerb line of Cornfield Street for a distance of 48 metres in a northerly direction

Pennine Drive School Layby, Milnrow & Newhey Ward

- (i) the east side for its entire length (a distance of 65 metres)
(ii) the east side for its entire length (a distance of 65 metres)
(iii) the west side for the entire length (a distance of 48 metres)
(iv) the west side for the entire length (a distance of 48 metres)
