- That part of the Borough of Rochdale (Civil Enforcement of Traffic Contraventions) 3. (Various Streets) (Middleton Township) Order 2008, as shown in Schedule 2 to this Order be hereby revoked
- The Interpretation Act 1978 shall apply for the Interpretation of this Order as it applies for the interpretation of an Act of Parliament.
