HUDDERSFIELD ROAD & RAILWAY STREET, NEWHEY, ROCHDALE

The Rochdale Borough Council, in exercise of its powers under Sections 1(1), 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Section 124(1) and paragraph 20(1) of Part III of Schedule 9 to the Act, hereby make the following Order:-

- This Order may be cited as the Borough of Rochdale ((Civil Enforcement of Traffic Contraventions) (Various Streets) (Pennines Township) Order 2008) (Amendment) (No. 39) Order 2013 Hudedersfield Road & Railway Street, Newhey, Rochdale and shall come into operation on 1st June 2013.
- 2. The Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Pennines Township) Order 2008 is hereby amended by inserting the wording shown in Schedule One to this Order.
- 3. Those parts of the Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Pennines Township) Order 2008, as shown in Schedule Two to this Order be hereby revoked.
- 4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

- n (i) the north westerly side from a point 110 metres south west of a point opposite the south westerly kerb line of Railway Street to a point 50 metres south west of a point opposite the south westerly kerb line of Railway Street
- n (ii) the north westerly side from a point 17 metres south west of a point opposite the south westerly kerb line of Railway Street to a point 1 metre south west of a point opposite the south westerly kerb line of Railway Street
- n (iii) the north westerly side from a point 24.56 metres north east of a point opposite the south westerly kerb line of Railway Street to its junction with Church Street

- n (iv) the south easterly side from a point 15 metres north east of its junction with Railway Street to its junction with Haugh Lane
