(AMENDMENT) (NO. 95) ORDER 2015

ENTWISLE ROAD, GOWERS STREET & BELFIELD ROAD, ROCHDALE

The Rochdale Borough Council, in exercise of its powers under Sections 1(1), 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Section 124(1) and paragraph 20(1) of Part III of Schedule 9 to the Act, hereby make the following Order:-

1. This Order may be cited as the Borough of Rochdale ((Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008) (Amendment) (No. 95) Order 2015 and shall come into operation on 1st June 2015.
2. The Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008 is hereby amended by inserting the wording shown in Schedule 1 to this Order.
3. Those parts of the Borough of Rochdale (Civil Enforcement of Traffic Contraventions) (Various Streets) (Rochdale Township) Order 2008, as shown in Schedule 2 to this Order be hereby revoked.
4. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

No Waiting 'At Any Time'

Entwisle Road, Central Rochdale Ward

- n (i) the south easterly side from its junction with Gowers Street to a point 15 metres south west of its junction with Gowers Street

Gowers Street, Central Rochdale Ward

- n(i) the south westerly side from its junction with Entwisle Road to a point 15 metres south east of its junction with Entwisle Road

Belfield Road, Kingsway Ward

- n (i) the northerly side from its junction with Beswicke Royds Street to a point 50 metres south east of its junction with Beswicke Royds Street
- n (ii) the southerly side from a point 29 metres south east of a point opposite the easterly kerb line of Beswicke Royds Street to a point 53 metres south east of a point opposite the easterly kerb line of Beswicke Royds Street

- (i) the north side from its junction with Beswicke Royds Street to a point 20 metres east of its junction with Beswicke Royds Street

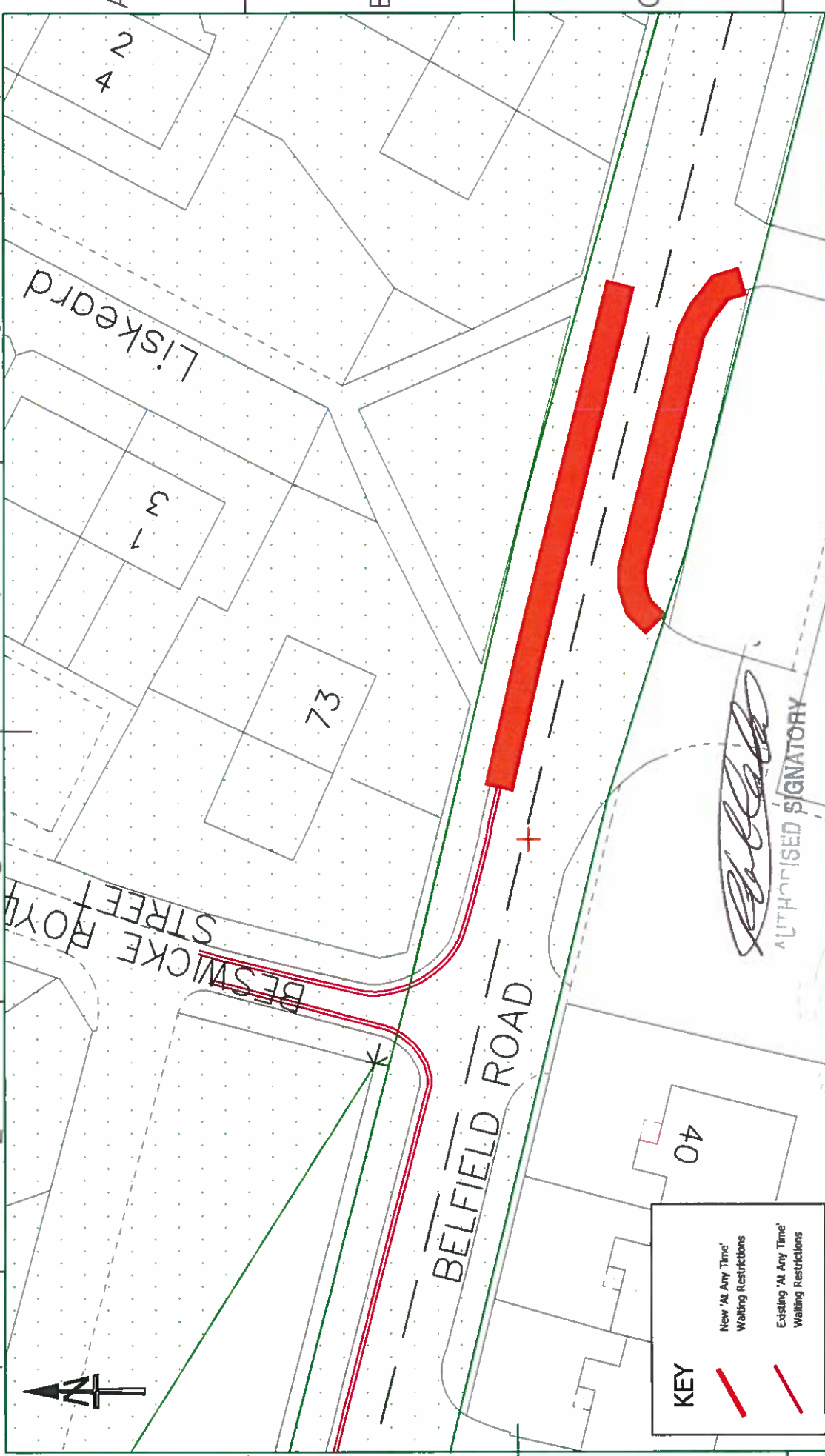

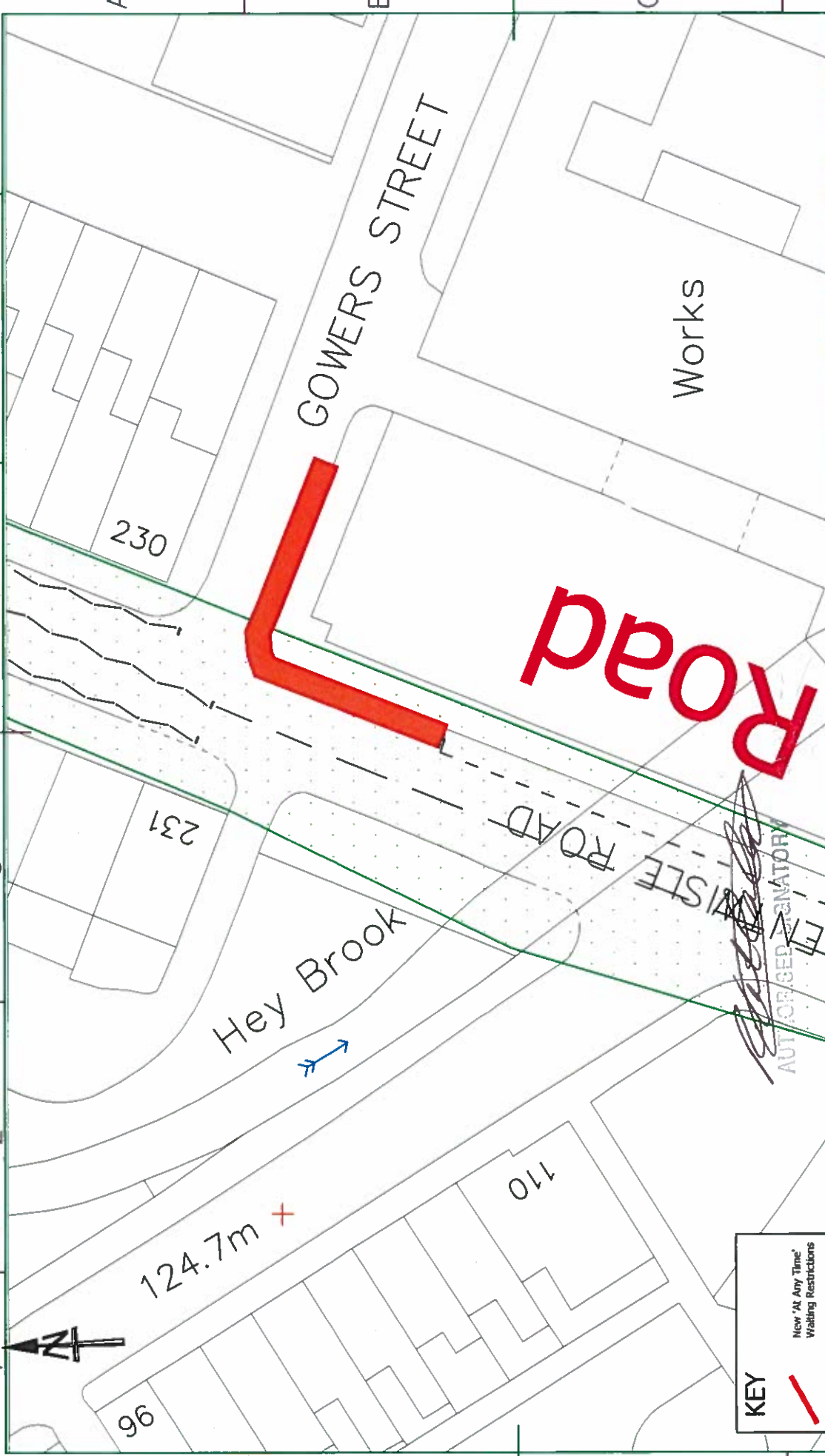
