



**THE ESSEX COUNTY COUNCIL (ROCHFORD DISTRICT)
(PROHIBITION OF WAITING, LOADING AND STOPPING) AND
(ON-STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA)
(AMENDMENT NO. 11) ORDER 2024**

NOTICE IS HEREBY GIVEN that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 30 June 2022 has made the above Order under Sections 1(1), 2(1) to (3), 4(1), 4(2), 32, 35, 45, 46, 49 and 53 and Parts III and IV of schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

Effect of the Order: To introduce or amend parking restrictions on the following lengths of road in the District of Rochford as specified below. All measurements are approximate and are taken from the extended kerb line unless stated otherwise.

1. To revoke ‘No Waiting Monday to Friday 11am-3pm’ and replace with ‘Limited Waiting Monday to Saturday 8am-6pm, 2 hours, no return within 2 hours’:

Road	Description
Castle Drive, Rayleigh	Northeast Side: From a point 18 metres southeast of its junction with A129 Station Road, south-eastwards for 15 metres. TILE: TQ800 910 Rev. 0 to Rev. 1

2. To introduce ‘No Waiting at Any Time’ restrictions:

Road	Description
Greenways, Rochford	Both Sides: From its junction with Oast Way, south-eastwards for 11 metres. TILE: TQ875 905 Rev. 1 to Rev. 2
Malting Villas Road, Rochford	Both Sides: From a point 13 metres southeast of its junction with Oast Way, north-westwards to a point 10 metres northwest of the junction. TILE: TQ875 907 Rev. 0 to Rev. 1
Oast Way, Rochford	Northwest Side: From its junction with Malting Villas Road, south-westwards to a point 12 metres west of its junction with Greenways. Southeast Side: From its junction with Malting Villas Road, south-westwards for 26 metres. Southeast Side: From a point 18 metres northeast of its junction with Greenways, south-westwards and north-westwards to a point 12 metres northwest its junction with Greenways. TILE: TQ875 905 Rev. 1 to Rev. 2, TQ875 907 Rev. 0 to Rev. 1

Following comments received during the formal consultation, the proposed ‘Permit Parking Area’ and ‘No Waiting at Any Time’ restrictions for Daws Heath Road, Woodlands Avenue and Woodlands Close, Rayleigh have been withdrawn. New proposals for these roads will be advertised in a new parking amendment.

Date of operation: This Order will come into operation on **26th February 2024**.

Application to the High Court: Anyone who wishes to question the validity of the Order, or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or any instrument made under it, has not been complied with in relation to the Order, may within six weeks from the making of the Order apply to the High Court for this purpose.
