

**THE ESSEX COUNTY COUNCIL (ROCHFORD DISTRICT)
(PROHIBITION OF WAITING, LOADING AND STOPPING) AND
(ON-STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA)
(AMENDMENT NO. 7) (PART 2) ORDER 2023**

NOTICE IS HEREBY GIVEN that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 30 June 2022 has made the above Order under Sections 1(1), 2 (1) to (3), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

Effect of the Order: To introduce parking restrictions on the following lengths of road in the District of Rochford as specified below. All measurements are approximate and are taken from the extended kerb line unless stated otherwise.

1. To introduce a 'Permit Parking Area Zone Q Mon - Fri 8am-10am and 2pm-4pm, excluding Bank Holidays':

Road	Description
Ashingdon Road, parking area/access road to property Nos. 116 – 144, Rochford	Both sides: From its junction with Ashingdon Road for its entire length. TILE: TQ870 912 Rev. 1 to Rev. 2

The Essex County Council (Rochford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 Schedule 5 will be amended to include the following properties the residents of which are eligible to apply for a permit:

Road	Zone	Properties
Ashingdon Road, Rochford	Q	Nos. 116 – 144 (evens)

The cost of a resident permit is £50 per year. Visitor Tickets are also available, valid for 1, 2, 4 and 6 hours or all day. Further details can be found on the Chelmsford Council website: www.chelmsford.gov.uk/parking

Date of Operation: This Order will come into operation on **6th November 2023**. Part 1 of the Order was made on 30th January 2023 and came into operation on 13th March 2023.

Application to the High Court: Anyone who wishes to question the validity of the Order, or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or any instrument made under it, has not been complied with in relation to the Order, may within six weeks from the making of the Order apply to the High Court for this purpose.

The Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an Agreement dated 30 June 2022 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") hereby makes the following Order under Sections 1(1), 2(1) to (3), 4(1) 4(2), 32, 35, 45, 46, 49, 53 and Part IV of Schedule 9 of the Act and of all other enabling powers.

1. This Order shall come into operation for all purposes on the 6th day of November 2023 and may be cited as The Essex County Council (Rochford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) (Amendment No. 7) (Part 2) Order 2023.
2. This Order will be incorporated into The Essex County Council (Rochford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 by substituting tile numbers TQ870 912 Revision 1 to Revision 2.
3. The Essex County Council (Rochford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 Schedule 5 will be amended to include the following properties the residents of which are eligible to apply for a permit:
