

**THE ESSEX COUNTY COUNCIL (ROCHFORD DISTRICT)  
(PROHIBITION OF WAITING, LOADING AND STOPPING) AND  
(ON-STREET PARKING PLACES) (CIVIL ENFORCEMENT AREA)  
(AMENDMENT NO.7) (PART 1) ORDER 2023**

**NOTICE IS HEREBY GIVEN** that Chelmsford City Council acting on behalf of the South Essex Parking Partnership in exercise of the delegated powers of the traffic authority Essex County Council granted under an agreement dated 31 March 2011 (and subsequently varied by Deed of Variation on 15 June 2011 and 27 July 2012) has made the above Order under Sections 1(1), 2 (1) to (3), 4(1), 4(2), 32(1), 35(1), 45, 46, 49, 53 and Parts III and IV of Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers.

**Effect of the Order:** To introduce or amend parking restrictions on the following lengths of road in the District of Rochford as specified below. All measurements are approximate and are taken from the extended kerb line unless stated otherwise.

**1. To revoke all existing parking restrictions and replace with a ‘Permit Parking Area Zone R Mon-Fri 10am-11am & 2pm-3pm excluding Bank Holidays’:**

Road	Description
<b>Kendal Close, Rayleigh</b>	<b>Northwest Side:</b> From its junction with Derwent Avenue south-westwards for 53 metres. <b>Southeast Side:</b> From its junction with Derwent Avenue south-westwards for 56 metres. TILE: TQ810 907 Rev 1 to Rev 2
<b>Keswick Close, Rayleigh</b>	<b>Both Sides:</b> From its junction with Derwent Avenue south-westwards then south-eastwards for its entire length. TILE: TQ810 907 Rev 1 to Rev 2

**2. To replace ‘No Waiting Mon-Fri 10am-11am’ restrictions with ‘No Waiting Mon-Fri 11am-12pm’:**

Road	Description
<b>Derwent Avenue, Rayleigh</b>	<b>Southwest Side:</b> From its junction with Kendal Close south-eastwards for 5 metres. TILE: TQ810 907 Rev 1 to Rev 2

**3. To introduce ‘No Waiting at Any Time’ restrictions:**

Road	Description
<b>Helena Road, Rayleigh</b>	<b>Southeast Side:</b> From its junction with Louise Road north-eastwards for 10 metres. TILE: TQ810 907 Rev 1 to Rev 2
<b>Louise Road, Rayleigh</b>	<b>Both Sides:</b> From its junction with Helena Road south-eastwards for 10 metres. TILE: TQ810 907 Rev 1 to Rev 2

The Essex County Council (Rochford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 Schedule 5 will be amended to include the following properties the residents of which are eligible to apply for a permit:

Road	Zone	Properties
Kendal Close, Rayleigh	R	All residential properties
Keswick Close, Rayleigh	R	All residential properties

The decision regarding the proposed 'Permit Area' on Ashingdon Road (parking area/access road to property Nos. 116 – 144), Rochford has been deferred until a later date. If approved, it will be included within Part 2 of this Order.

**Date of Operation:** This Order will come into operation on **Monday 13 March 2023**

**Application to the High Court:** Anyone who wishes to question the validity of the Order, or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or any instrument made under it, has not been complied with in relation to the Order, may within six weeks from the making of the Order apply to the High Court for this purpose.



3. The Essex County Council (Rochford District) (Prohibition of Waiting, Loading and Stopping) and (On-Street Parking Places) (Civil Enforcement Area) Consolidation Order 2019 Schedule 5 will be amended to include the following properties the residents of which are eligible to apply for a permit:
