No Waiting at Any Time
A629 Upper Wortley Road, Lodge Lane and Brook Hill, Thorpe Hesley,
Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time" of the 2011 Order
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1

Schedule 1 No Waiting At Any Time

A629 Upper Wortley Road

(ii) the south west side from a point 125 metres north west of the north western kerbline of Grange Lane for a distance of 184 metres in a south easterly direction.

Schedule 2

To be introduced

Schedule No 1
No Waiting At Any Time

A629 Upper Wortley Road

(ii) North side – from a point 20 west of where the extended northwestern kerbline of Brook Hill meets the extended northern kerbline of Upper Wortley Road, for a distance of 85 metres in an easterly direction.

South side – from a point 60m southeast of where the extended northeastern kerbline of Grange Lane meets the extended southern kerbline of Upper Wortley Road for a distance of 445 metres in a northwesterly direction.

Lodge Lane

Both sides – from its junction with the southern kerbline of Upper Wortley Road for a distance of 15 metres in a southwesterly direction.

Brook Hill

Northwest side – from its junction with the northern kerbline of Upper Wortley Road for a distance of 45 metres in a northwest west direction.

Northeast side – from its junction with the northern kerbline of Upper Wortley Road for a distance of 30 metres in a northwesterly direction.

This Order is made on the 12th. May 2022 and shall come into force on the 16th. May 2022 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.204) Order 2022
