Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order') shall have effect as though the words specified in the Schedule hereto were included in Schedule 35 Part 5 of the 2011 Order 'Residents Parking Zone Monday to Friday 9am to 4pm'

<b>Mortain Road, Rotherham</b> Both sides from its junction with Woodfoot Road to a point 15m south west of the south western kerb line of Lymister Road	Close by and parallel with the kerb	Vehicles which display a valid Permit	Mon-Fri (inclusive)	9am-4pm

Exemptions will apply to the Residents Parking Zone restrictions for non-permit holders for a maximum stay 1 hour, no return on 3 hours, to enable a vehicle to wait for passengers to board or alight, for disabled badge holders, for loading and unloading of goods, for enabling work to be carried out in or adjacent to the road and for emergency service vehicles.

This Order is made on the 8<sup>th</sup>. March 2023 and shall come into force on the 13<sup>th</sup>. March 2023 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.209) Order 2023.
