Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

- 2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order) shall have effect as though:
  - (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order 'No waiting at any time' under the headings and numbered items specified therein
  - (ii) the words specified in Schedule 1 hereto were deleted from Schedule 53 of the 2011 Order 'Loading/Unloading Mon-Sat 8am-6pm' under the headings and numbered items specified therein
  - (iii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order 'No waiting any time' under the headings and numbered items specified therein

Broom Road, Rotherham

- i South west side from its junction with the south eastern kerb line of Fraser Road for a distance of 28 metres in a south easterly direction
- ii South west side form its junction with the north western kerb line of Fraser Road, to its junction with the south eastern kerb line of Broom Terrace

### Wellgate Rotherham Town Centre

ii. The north east side from a point 10m north west of the north western kerb line of Clifton Terrace to its junction with the western kerb line of Clifton Lane roundabout.

# Broom Road, Broom

- (iii) north east side from its junction with the north western kerb line of Boswell Street for a distance of 15 metres in a north westerly direction
- (ix) south west side from the north western kerb line of Broomfield Grove for a distance of 20 metres in a north westerly direction

# Wellgate Rotherham Town Centre

The north east side from a point 24 metres north west of the northern kerb line of Clifton Terrace for a distance of 13 metres in a north westerly direction

### Schedule 1 No waiting at any time:

#### **Broom Road, Rotherham**

- i the south west side from a point 15m south east of the south eastern kerb line of Broom Terrace to a point 28 metres south east of the south eastern kerb line of Fraser Road.
- ii the north east side from the south eastern kerb line of Boswell Street to a point 28metres south east of a projection of the south eastern kerb line of Fraser Road.
- iii The south west side from the north western kerb line of Broomfield Grove for a distance of 10 metres in a north westerly direction

#### Wellgate Rotherham

I. The south west side from a point 35 metres north west of the western kerb line of broom valley Road to a point 10m south east of the eastern kerb line of Bernard Street.

II. The north east side from a point 5m north west of the north western kerb line of Clifton Terrace to its junction with the western kerb line of Clifton Lane roundabout.

This Order is made on the 20<sup>th</sup>. September 2023 and shall come into force on the 25<sup>th</sup>. September 2023 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.212) Order 2023.
