No waiting at any time  
Church Street, Wales, Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though:

- (i) the words specified in Schedule 1 hereto were deleted from Schedule 1 of the 2011 Order "No Waiting At Any Time"
- (ii) the words specified in Schedule 2 hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1 No Waiting at Any Time

**Church Street**

- (i) the eastern kerb line from the junction with the southern kerb line of Wales Road for a distance of 16 metres in a south westerly direction;
- (ii) the west side from the north side of Orchard Lane for a distance of 8 metres in a northerly direction;
- (iii) the east side from a point 21 north of the projected north side of Orchard Lane for a distance of 41 metres in a southerly direction;

## Schedule 2

To be introduced

### Schedule 1 No Waiting at Any Time

#### Church Street

- (i) the eastern side from the junction with the southern kerb line of Wales Road for a distance of 19 metres in a south westerly direction;
- (ii) the western side from the north side of Orchard Lane for a distance of 6 metres in a northerly direction;
- (iii) the east side from a point 21 north of the projected north side of Orchard Lane for a distance of 36 metres in a southerly direction;
- (iv) the western side from a point 19 metres from the south-western kerb line of School Road for a distance of 18 metres in a southerly direction;

This Order is made on the 31<sup>st</sup>. May 2018 and shall come into force on the 4<sup>th</sup>. June 2018 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.158) Order 2018.
