

**THE ROTHERHAM BOROUGH COUNCIL
SCHOOLS CLEARWAY (ROTHER VALLEY SOUTH) ORDER 2013
(AMENDMENT NO.1) ORDER 2015**

Edinburgh Drive Anston Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

1. The Rotherham Borough Council Schools Clearway (Rother Valley South) Order 2013 ("the 2013 Order") shall have effect as though:-

- (i) the words specified in Schedule 1 hereto were deleted from the Schedule of the 2013 Order 'No Stopping or Waiting - Monday to Friday during the hours of 07.30 am to 05.00 pm'
- (ii) the words specified in Schedule 2 hereto were included in the Schedule of the 2013 Order 'No Stopping or Waiting - Monday to Friday during the hours of 07.30 am to 05.00 pm'

Schedule 1

To be revoked

Schedule 1: No Stopping or Waiting - Monday to Friday during the hours of 7:30am to 5:00pm.

Edinburgh Drive outside Anston Greenlands School

Edinburgh Drive on the north-western kerb line from a point 92 metres north of the intersection between the extended eastern kerb line of Wellington Avenue and the north-western kerb line of Edinburgh Drive, for a distance of 25.56 metres in a northerly direction.

Schedule 2

To be introduced

Schedule 2: No Stopping or Waiting - Monday to Friday during the hours of 7:30am to 5:00pm.

Edinburgh Drive outside Anston Greenlands School

Edinburgh Drive on the north-western kerb line from a point 116 metres north of the intersection between the extended eastern kerb line of Wellington Avenue and the north-western kerb line of Edinburgh Drive, for a distance of 37.56 metres in a northerly direction.

2. This Order is made on the 21st. May 2015 and shall come into force on the 25th. May 2015 and may be cited as "The Rotherham Borough Council Schools Clearway (Rother Valley South) Order 2013 (Amendment No.1) Order 2015.
