Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order') shall have effect as though the words specified in the Schedule hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1 No Waiting at Any Time

Knollbeck lane, Brampton

- i

Western kerbline from the extended North Western kerbline of Garden Drive for a distance of 20.00m in a North Westerly direction.

- ii

Western kerbline from the extended South eastern kerbline of Garden Drive for a distance of 12.00m in a South Easterly direction.

- iii

Eastern kerbline from the extended North Western kerbline of Chapel Avenue for a distance of 50.00m in a North Westerly direction.

- iv Eastern kerblines from the extended South eastern kerblines of Chapel Avenue for a distance of 5.50m in a South Easterly direction.

Garden Drive, Brampton

- i Both sides from the extended Western kerblines of Knollbeck Lane for a distance of 30.00m.

Dearne Road, Brampton

- i Western kerblines from the extended Northern kerblines of Chapel Avenue for a distance of 15.00m in a Northerly direction.
- ii Eastern kerblines from the extended Northern kerblines of Chapel Avenue for a distance of 13.00m in a Northerly direction.

Chapel Avenue, Brampton

- i Northern kerblines from the extended Eastern kerblines of Dearne Road for a distance of 17.00m in an easterly direction.
- ii Southern kerblines from the extended North Eastern kerblines of Knollbeck Lane for a distance of 27.00m in an Easterly direction.

Schedule 10 No Waiting Mon-Sat 8am-6pm

Knollbeck lane, Brampton

Western kerbline from a point 12.00m from the extended South eastern kerbline of Garden Drive for a distance of 31.00m in a South Easterly direction.

This Order is made on the 12th. January 2017 and shall come into force on the 16th. January 2017 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.125) Order 2017.
