Mansfield Road and Waleswood Way Kiveton Park Sheffield

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order') shall have effect as though the words specified in the Schedule hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule 1 No Waiting at Any Time

Mansfield Road, Kiveton Park

i

North Eastern kerbline from the extended North Western kerbline of Waleswood Way for a distance of 20.00m in a North Westerly direction.

ii

North Eastern kerbline from the extended South Eastern kerbline of Waleswood Way for a distance of 20.00m in a South Easterly direction.

Waleswood Way, Kiveton Park

- i North Western kerbline from the extended North Eastern kerbline of Mansfield Road for a distance of 76.00m in a North Easterly direction.
- ii South Eastern kerbline from the extended North Eastern kerbline of Mansfield Road for a distance of 97.00m in a North Easterly direction.
- iii Southern kerbline from the extended Eastern kerbline of the unadopted section of Waleswood Way (adjacent to unit E) for a distance of 133.00m in an Easterly direction.
- iv Southern kerbline from the extended Eastern kerbline of the unadopted section of Waleswood Way (adjacent to unit J) to a point on the Northern kerbline 44.00m from the Eastern kerbline.
- v Northern kerbline from the extended Eastern kerbline of the unadopted section of Waleswood Way (adjacent to unit 1) for a distance of 15.00m in an Easterly direction.
- vi Northern kerbline from the extended Western kerbline of the unadopted section of Waleswood Way (adjacent to unit 4) for a distance of 15.00m in a Westerly direction.
- vii Northern kerbline from the extended Eastern kerbline of the unadopted section of Waleswood Way (adjacent to unit D) for a distance of 15.00m in an Easterly direction.

This Order is made on the 5th. October 2017 and shall come into force on the 9th. October 2017 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.156) Order 2017.
