Chesterton Road Chesterton Way and Sycamore Road Eastwood Rotherham

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ("the 2011 Order") shall have effect as though the words specified in the Schedule hereto were included in Schedule 1 of the 2011 Order "No Waiting At Any Time"

Schedule

Schedule 1 No Waiting at Any Time

Chesterton Road, Eastwood.

- i Western kerbline from the extended Northern kerbline of Fitzwilliam Road for a distance of 92.00m in a North-westerly direction.
- ii South-western kerbline from the extended western kerbline of unspecified entrance for a distance of 124.00m in a North-westerly direction.
- iii South-western kerbline from the extended Northern-western kerbline of unspecified entrance for a distance of 130.00m in a North-westerly direction.
- iv North-eastern kerbline from the extended North-western kerbline of Chesterton Way for a distance of 10.00m in a North-westerly direction.

- v Eastern kerbline from the extended Northern kerbline of Fitzwilliam Road for a distance of 24.00m in a Northerly direction.
- vi Northern kerbline from the extended Western kerbline of unspecified entrance for a distance of 29.00m in a Westerly direction.
- vii North-western kerbline from the extended Western kerbline of unspecified entrance for a distance of 10.00m in a South-westerly direction.

Chesterton Way, Eastwood.

- i Both sides in a North-easterly direction for a distance of 15.00m from the extended North-eastern kerbline of Chesterton Road

Sycamore Road, Eastwood.

- i Northern kerbline from the extended Eastern kerbline of Chesterton Way for a distance of 45.00m in an Easterly direction
- ii Southern kerbline from the extended Eastern kerbline of Chesterton Road for a distance of 24.00m in an Easterly direction

This Order is made on the 27th. August 2015 and shall come into force on the 31st. August 2015 and may be cited as "The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 (Amendment No.92) Order 2015.
