(AMENDMENT NO 41) ORDER 2014

Rotherham Borough Council in exercise of its powers under Sections 1, 2, 4, 45, 46, 49, 53 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 ("the RTRA 1984"), the Traffic Management Act 2004 ("the TMA 2004"), the Civil Enforcement of Parking Contraventions (England) General Regulations 2007 ("CEoPC General Regulations 2007") and all other enabling powers and after consulting the Chief Officer of Police in accordance with Part III of Schedule 9 to the RTRA 1984 and in pursuance of the Road Traffic (Permitted Parking Area and Special Parking Area) (Metropolitan Borough of Rotherham) Order 2005 made by the Secretary of State for Transport hereby makes the following Order:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulation Consolidation) Order 2011 ('the 2011 Order') shall have effect as though the following words were included in Schedule 1 "No Waiting At Any Time" of the 2011 Order under the heading specified in the Schedule below:-

Schedule 1 No Waiting at Any Time

St. Anns Road Eastwood

Eastern kerbline from a point 22.00m South of the extended Southern Kerbline of Bramwell Street, in a southerly direction for the whole of St Anns Road to a point on the western kerbline 22.00m south of the extended kerbline of Bramwell Street.

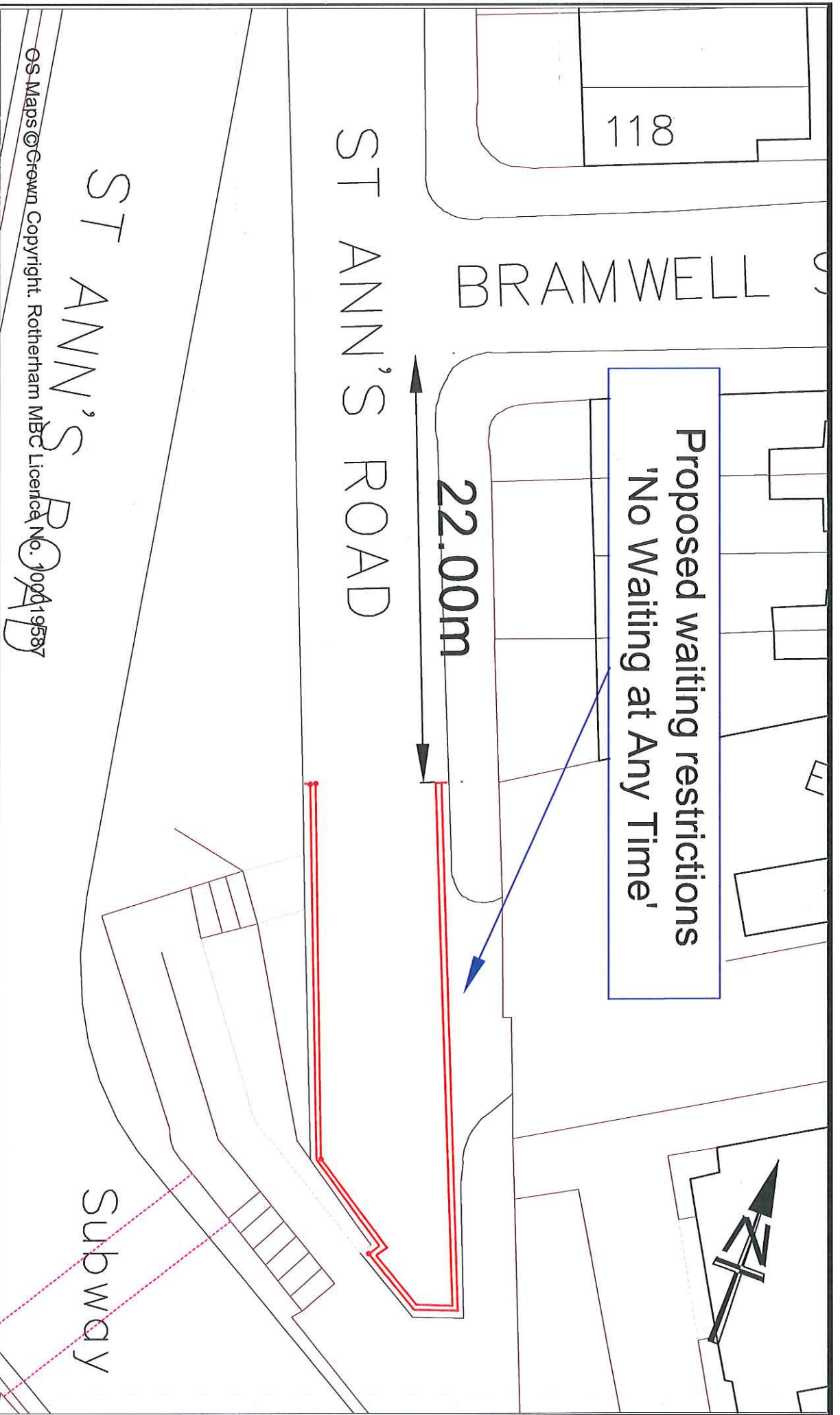
