1. Rotherham Borough Council in exercise of its powers under Section 1(1), 2(1) and (2) and 4(2) of Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter called “the Act”) and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order, the sole effect of which is to reproduce and continue in force the provisions of the Experimental Traffic Regulation Order to amend The Rotherham Borough Council (Various roads, Rotherham) (Traffic Regulation consolidation) Order 2011 Order 2016 Pay and display Zone 8am-6pm (Mon-Sat) inclusive Maximum stay 2 hours (no return within 1 hour) and Residents Parking Space Monday to Friday 9am-4pm (Eastwood South, Residents Parking Norfolk Street Rotherham Town Centre:-

2. The Rotherham Borough Council (Various Roads, Rotherham) (Traffic Regulations Consolidation) Order 2011 (“the Order”) shall have effect as though:-

- (i) the words specified in Schedule 1 hereto were deleted from the Schedule 44 part 2 of the Order “Mon-Sat 8am-6pm Maximum stay 2 hrs no return within 1 hour”
- (ii) the words specified in Schedule 2 hereto were included in Schedule 35 part 4 of the Order “Residents parking space Monday to Friday 9am-4pm”
